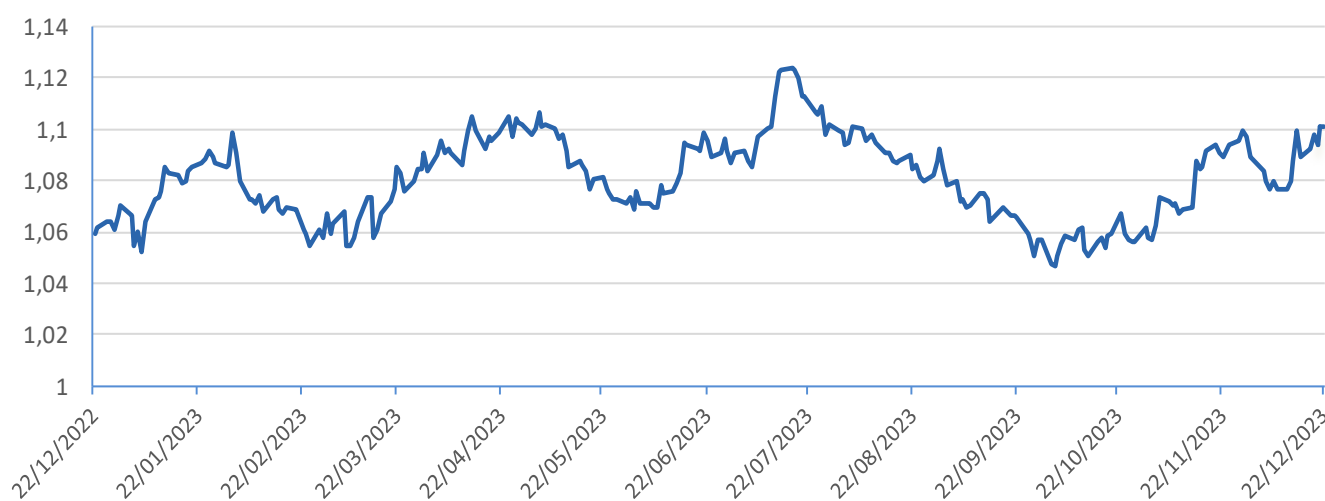

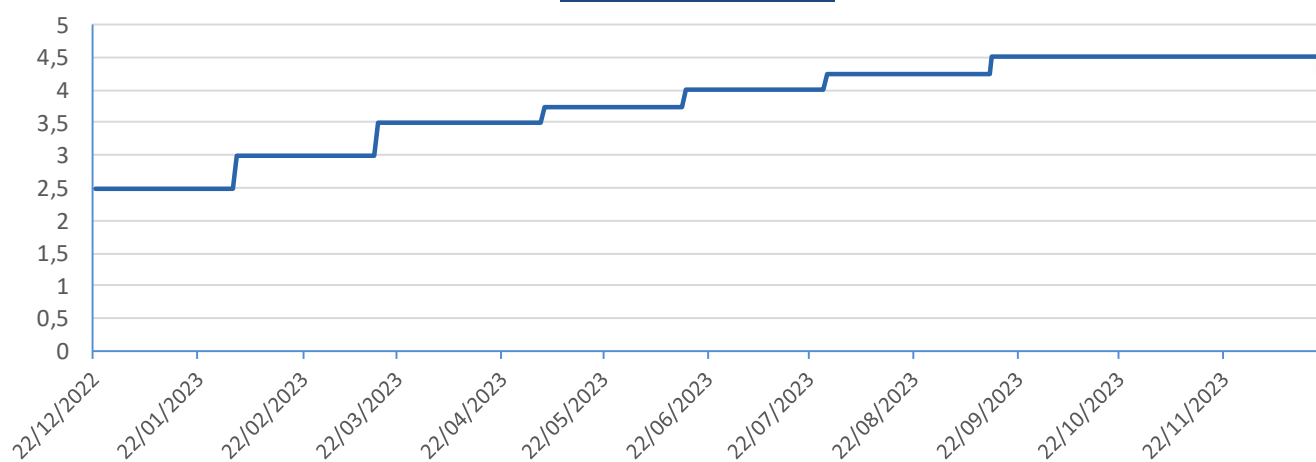

ECB Refinancing rate

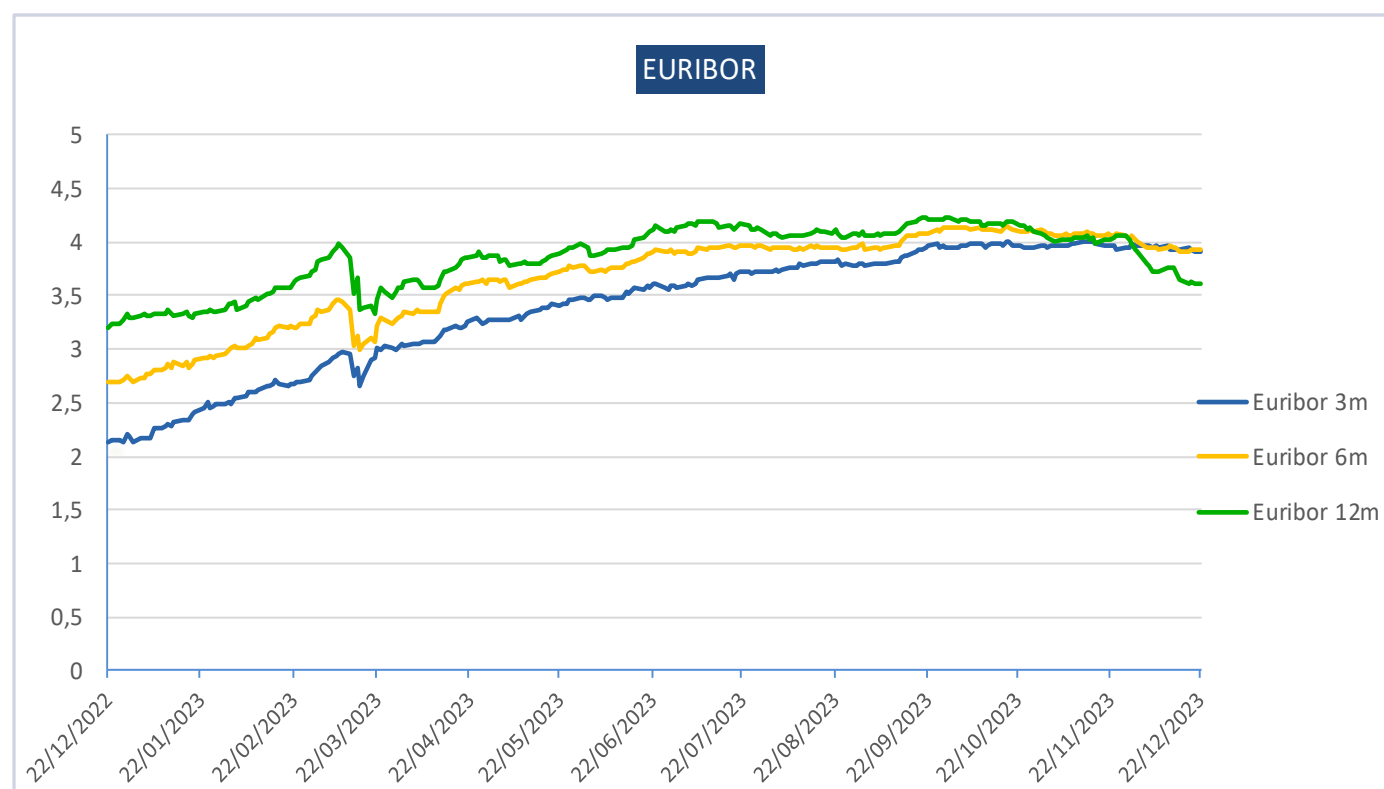
