EURUSD spot rate



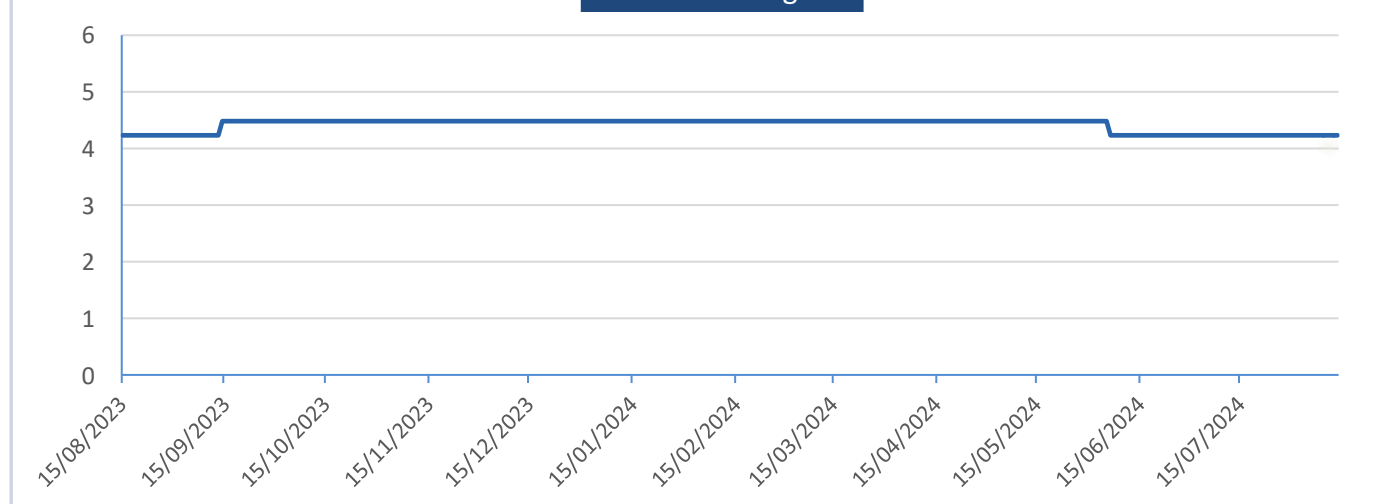

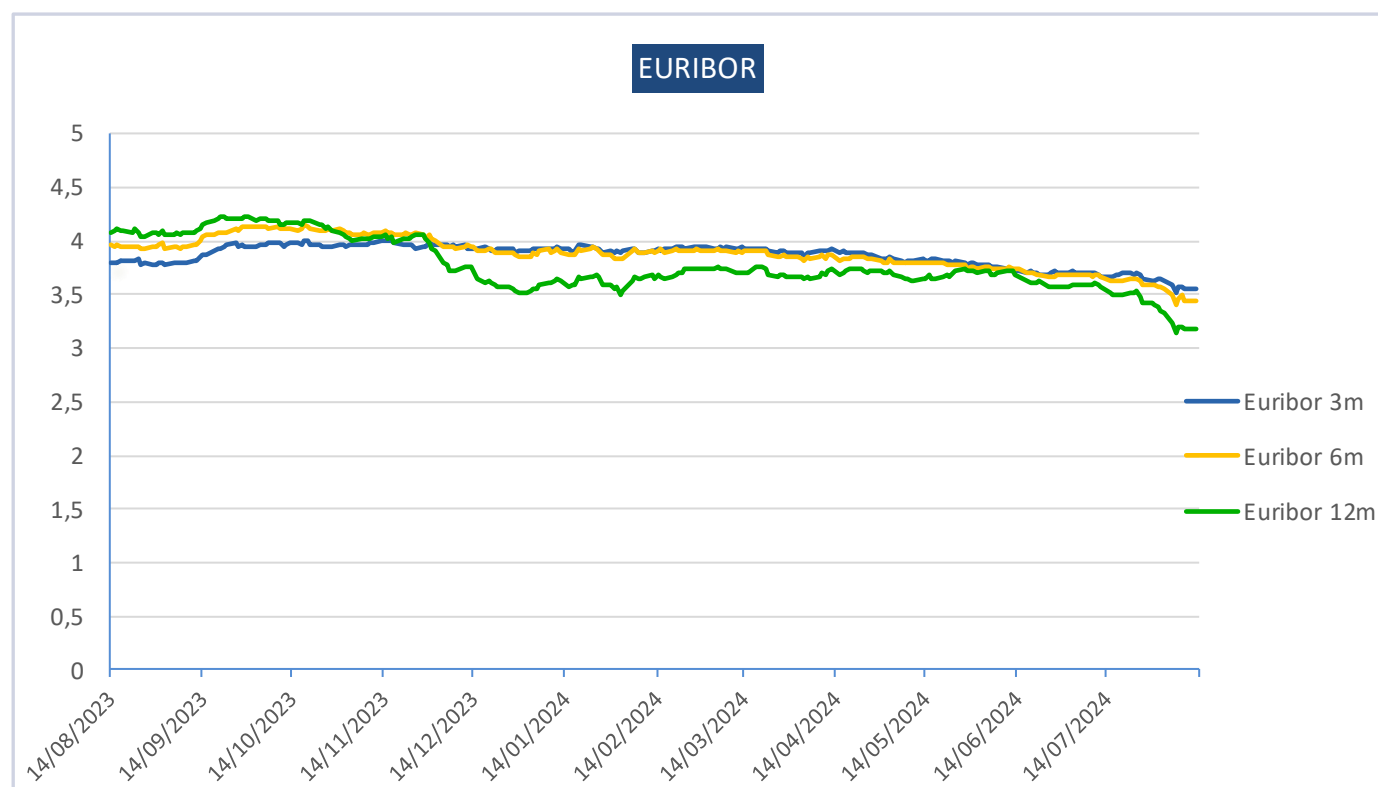
ECB Refinancing rate

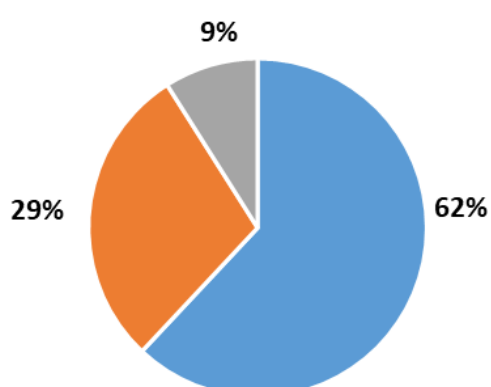

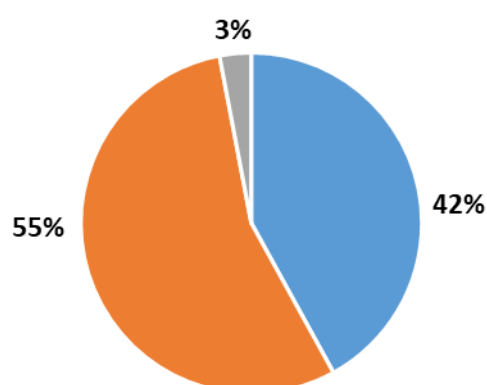

Distribution by Geography



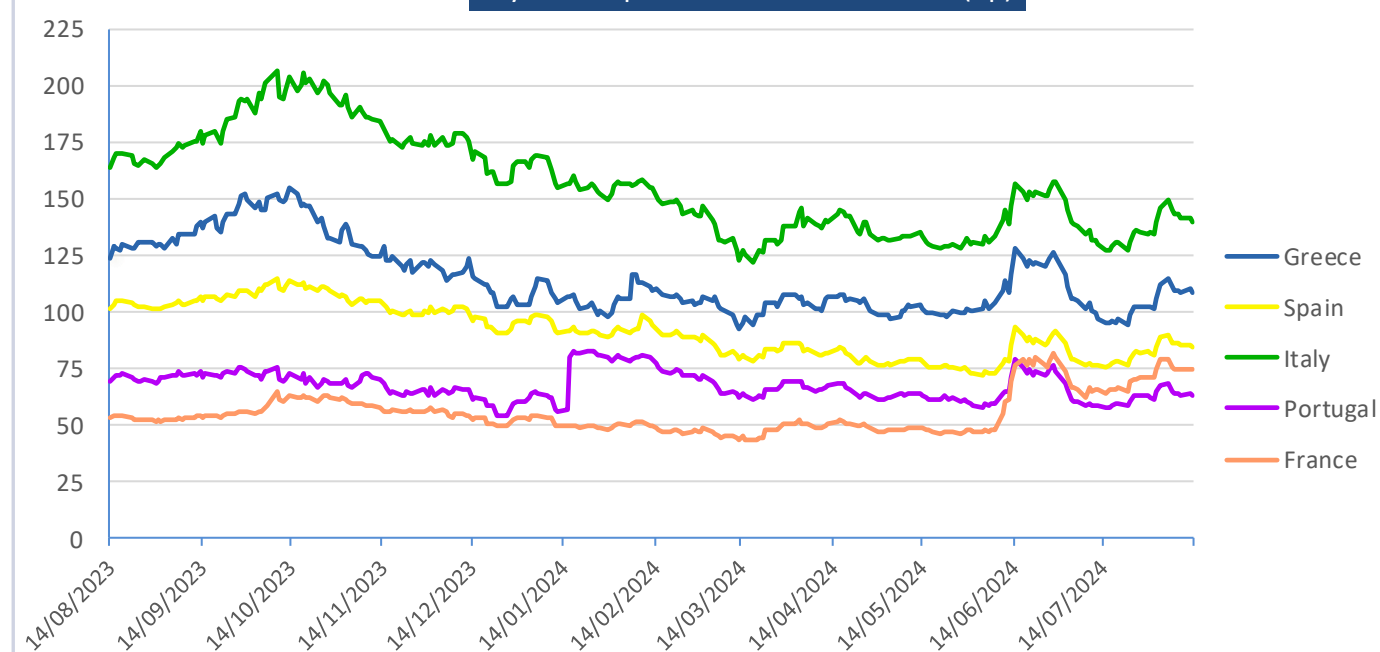

BONDS SPREAD OVER GERMAN BUND (bp)

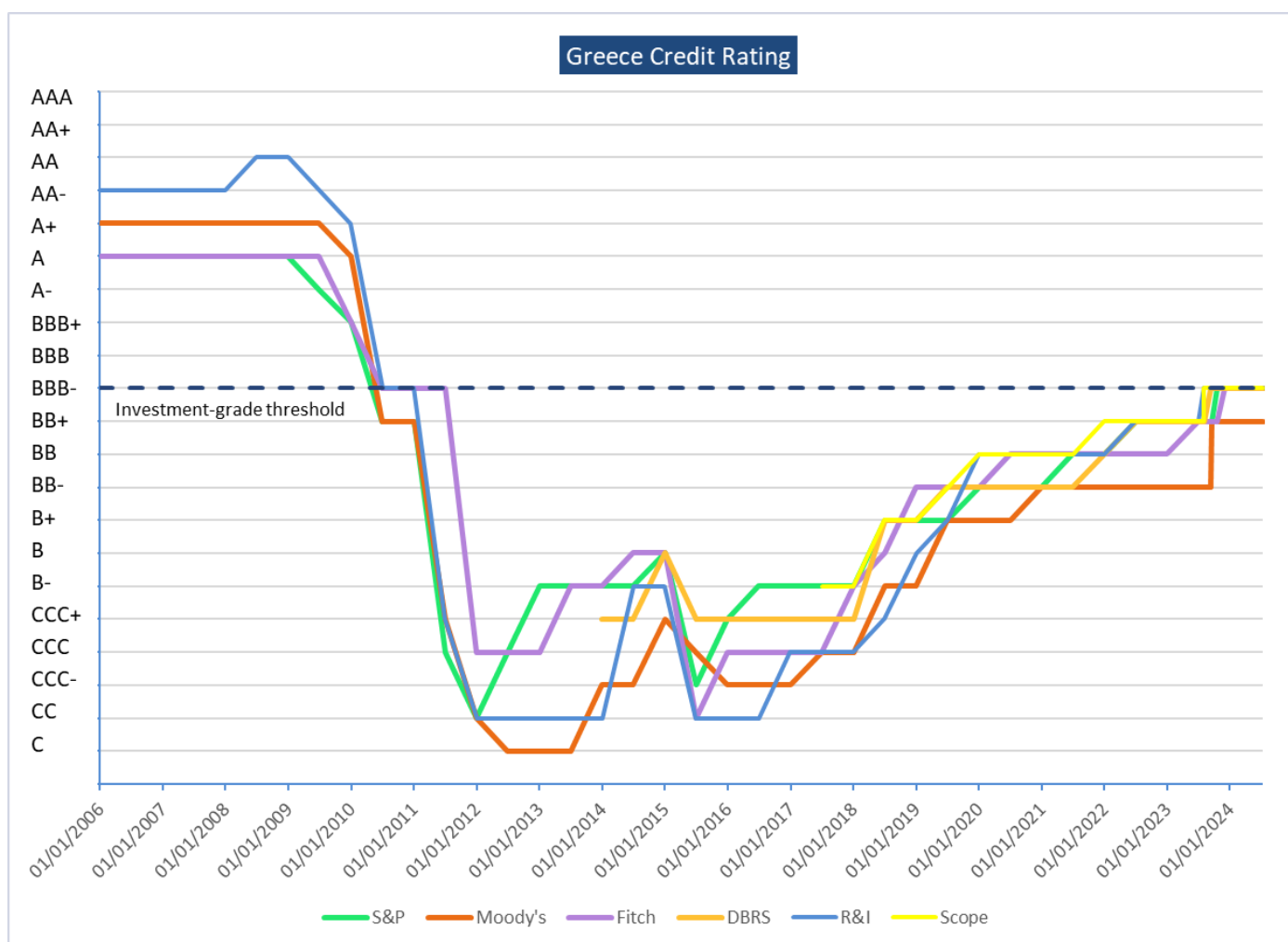

10y-Bond Spread over German Bund (bp)




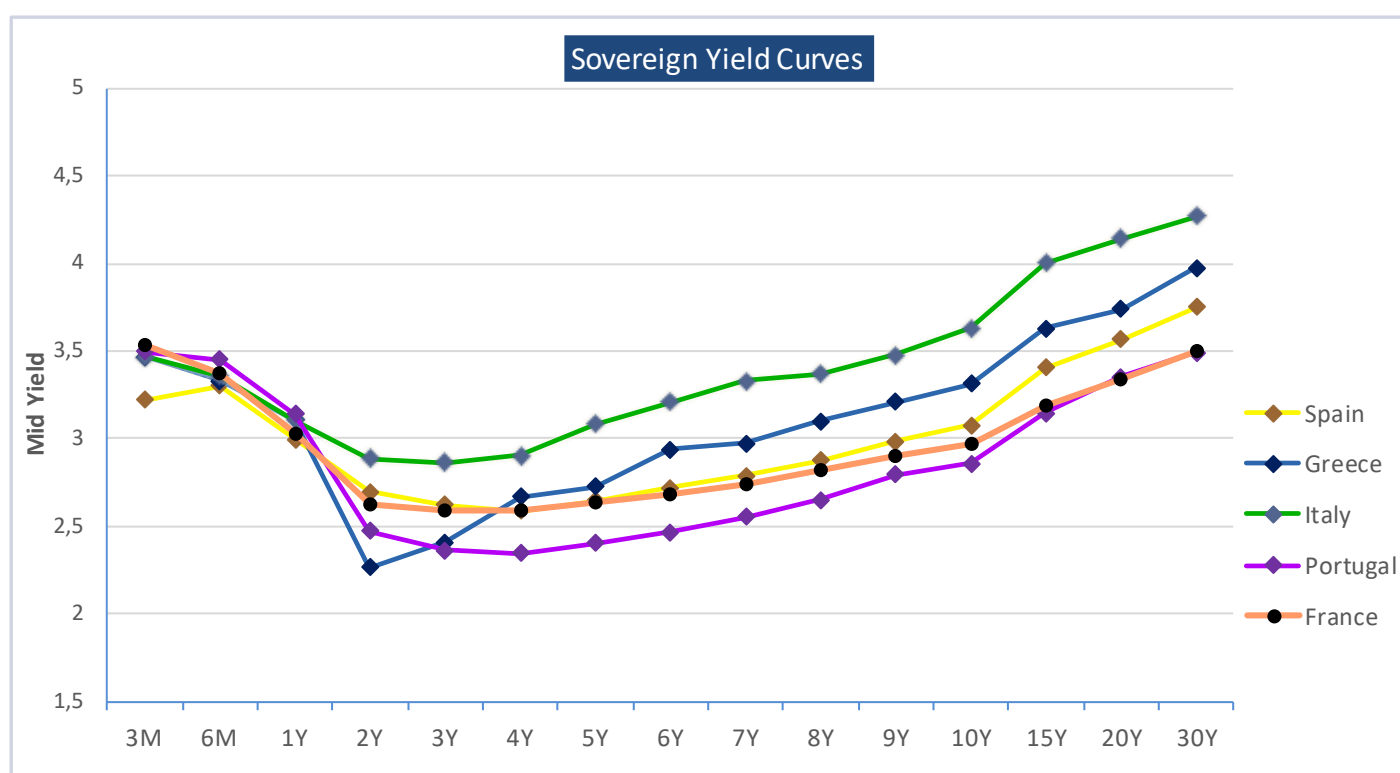

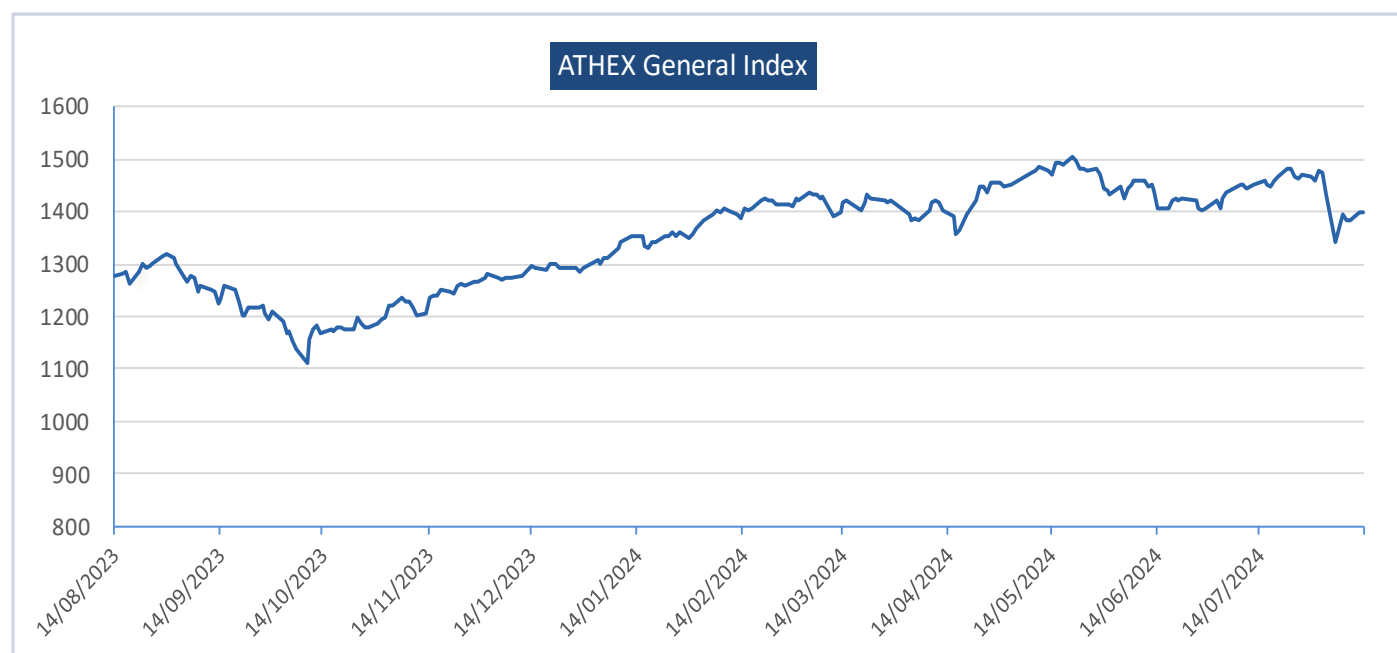

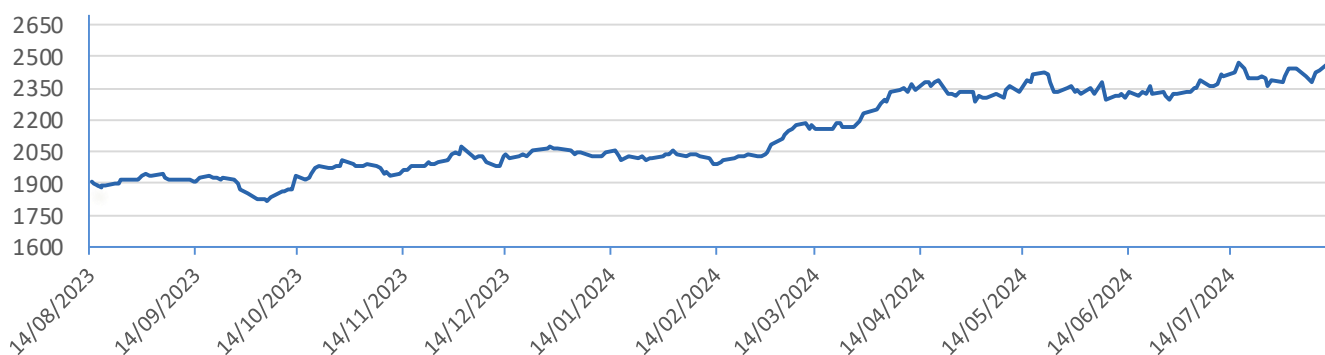

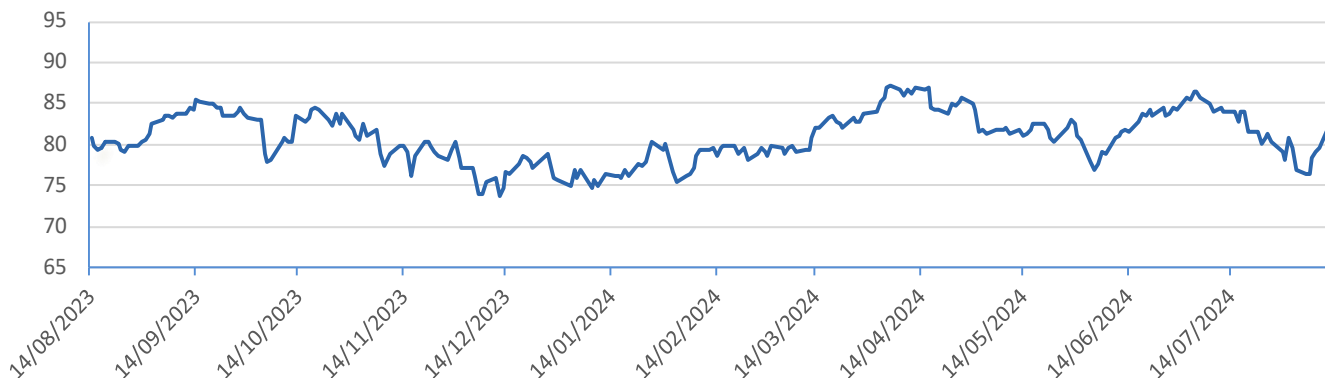
Gold spot (\$/Oz)
