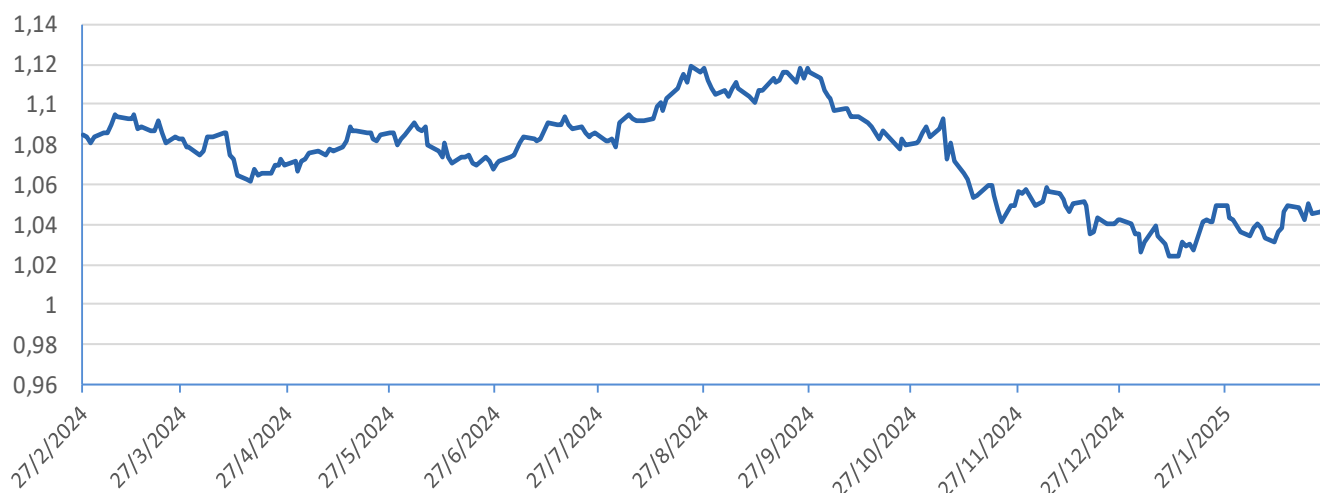

EURUSD spot rate



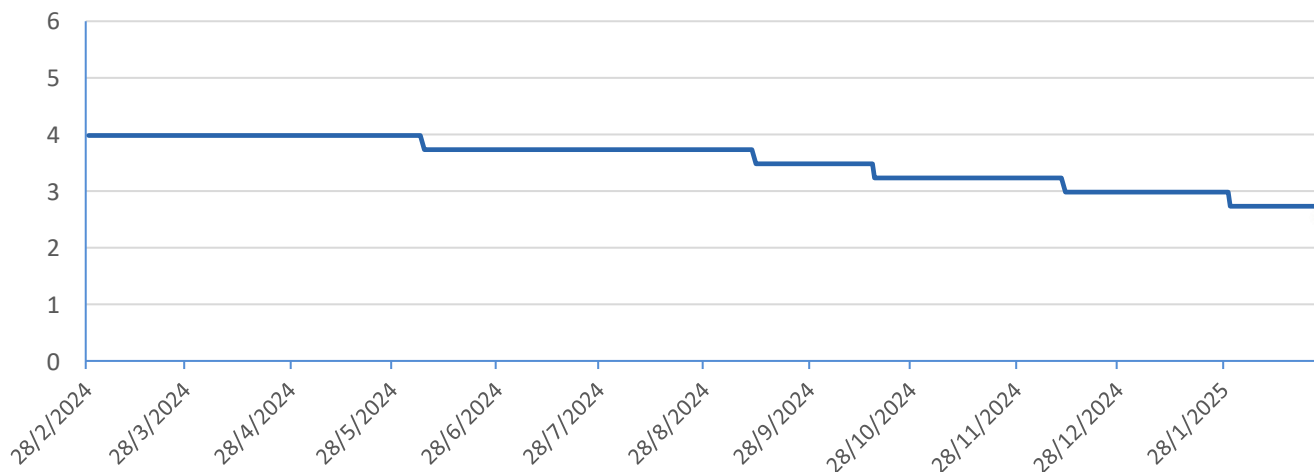

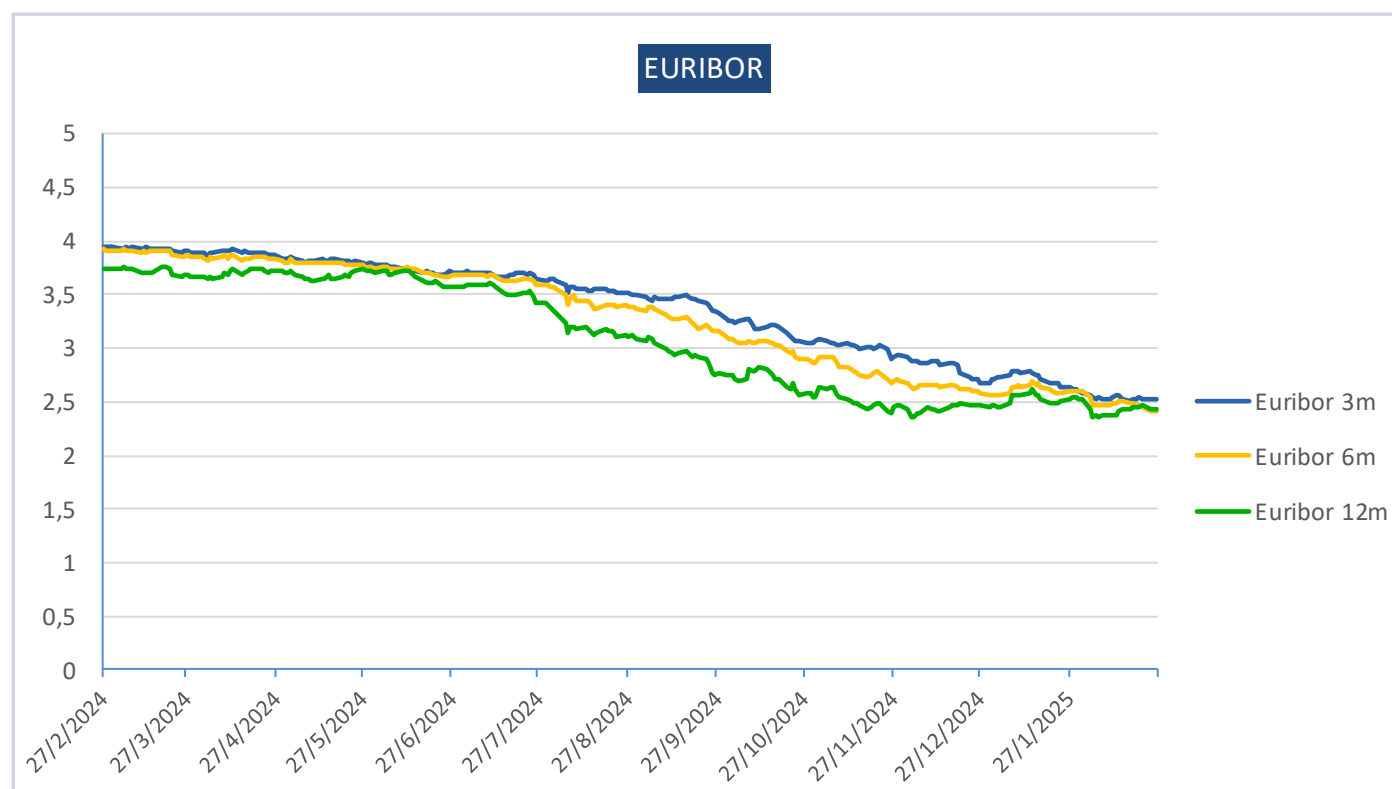

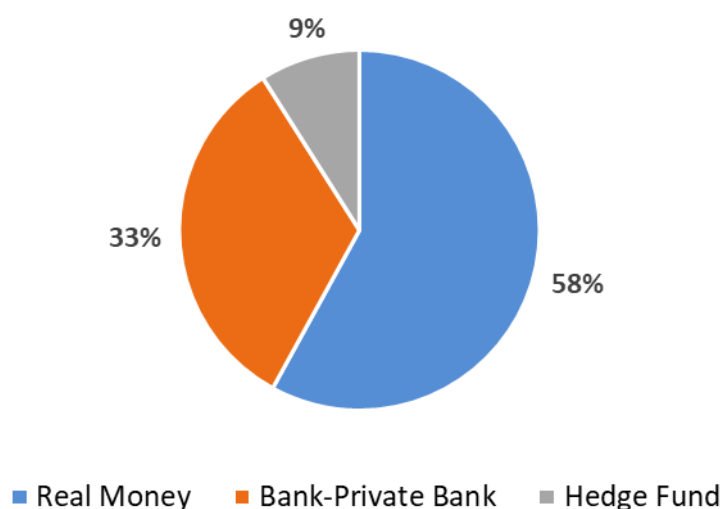

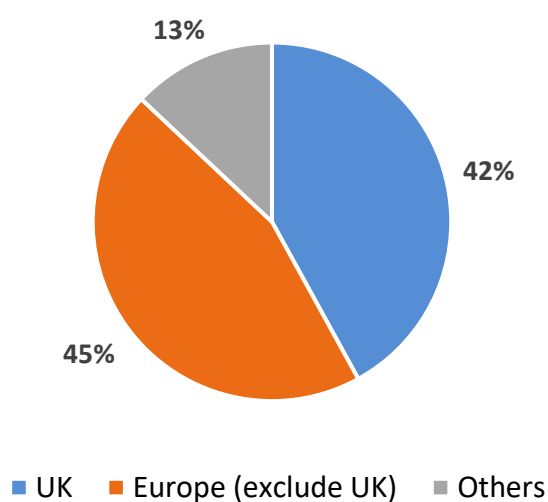

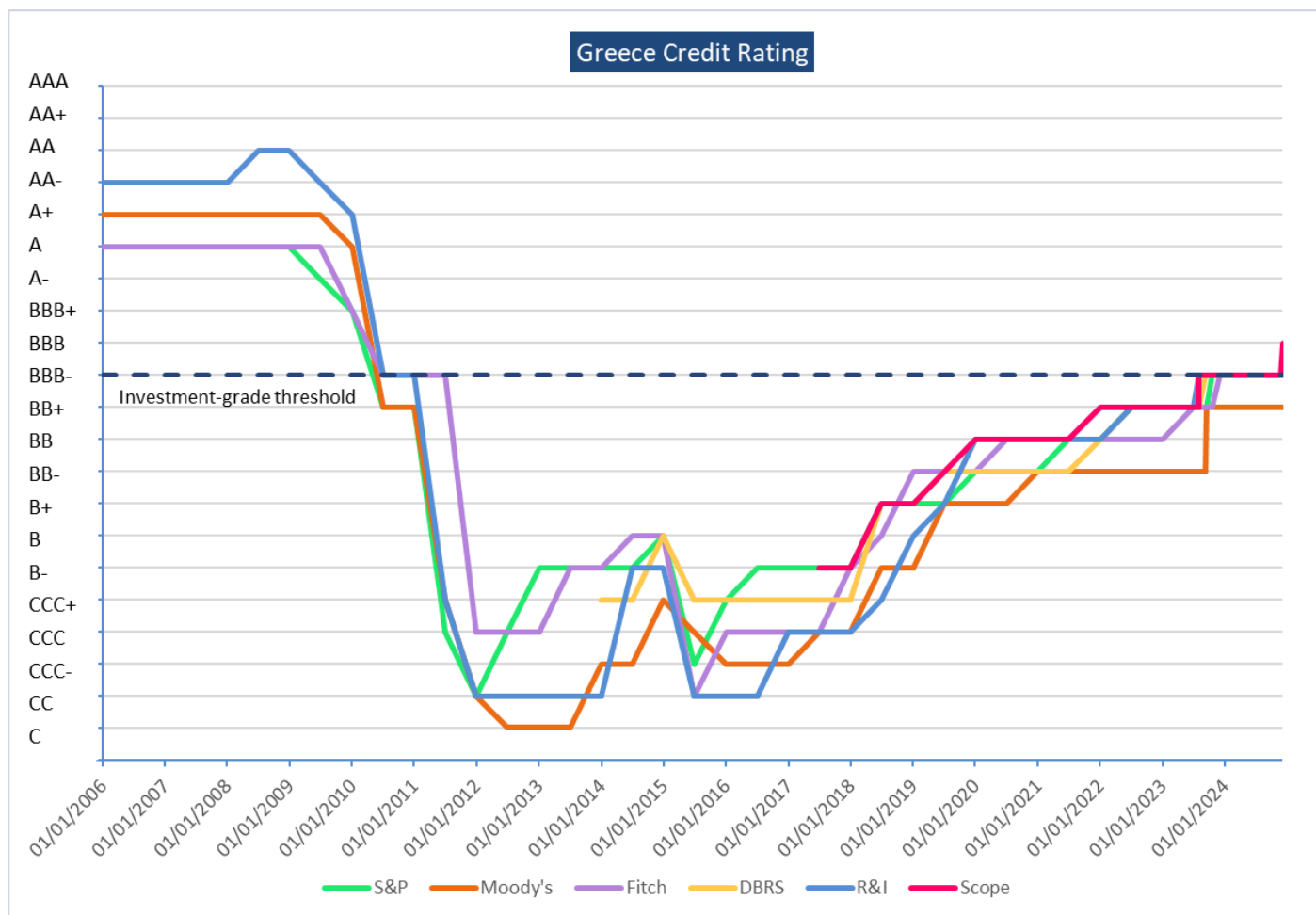

10y-Bond Spread over German Bund (bp)



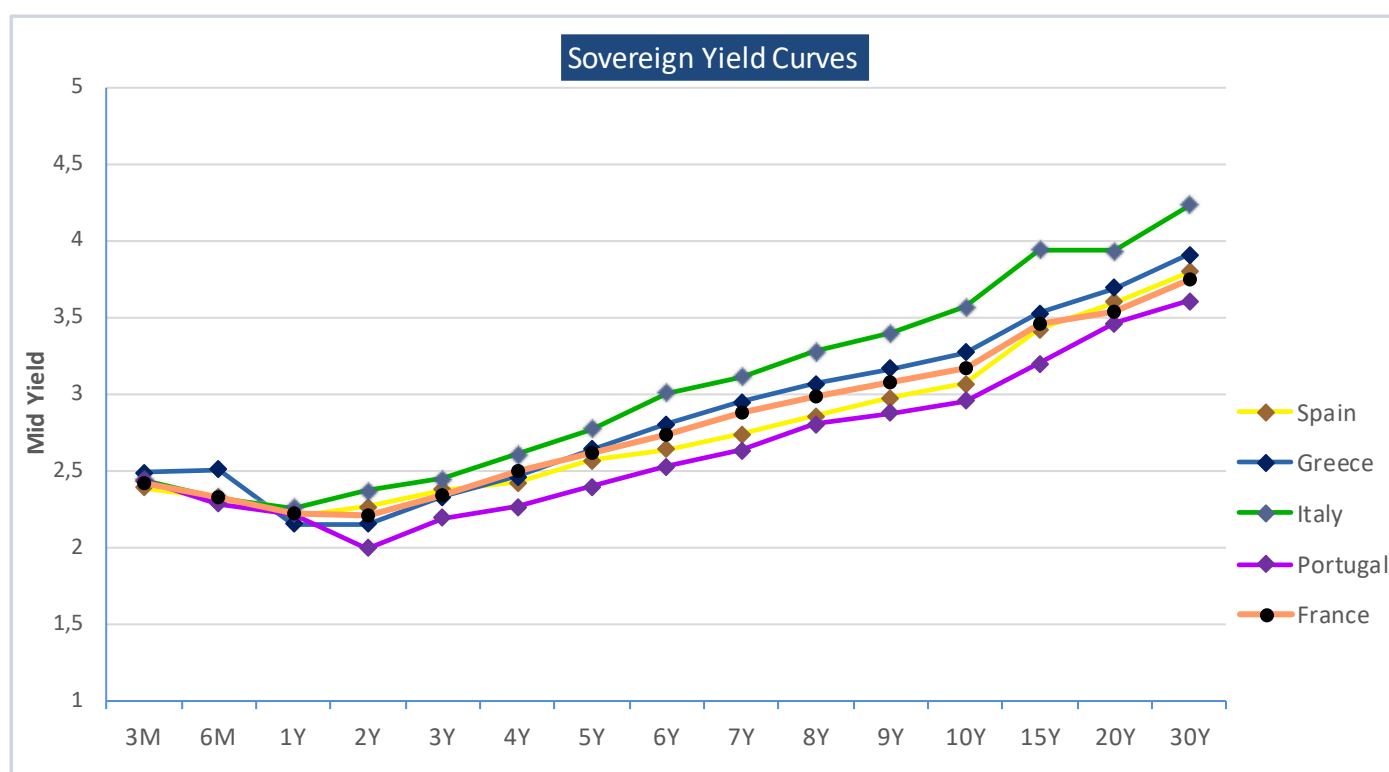

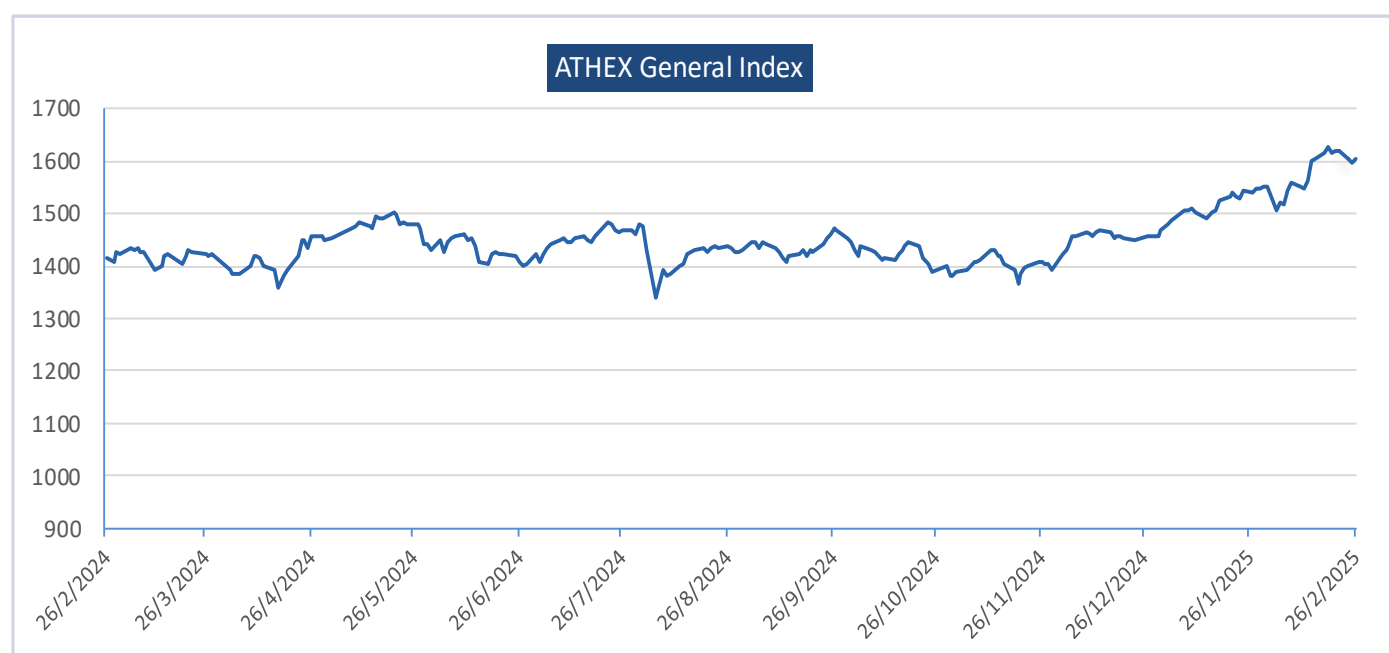

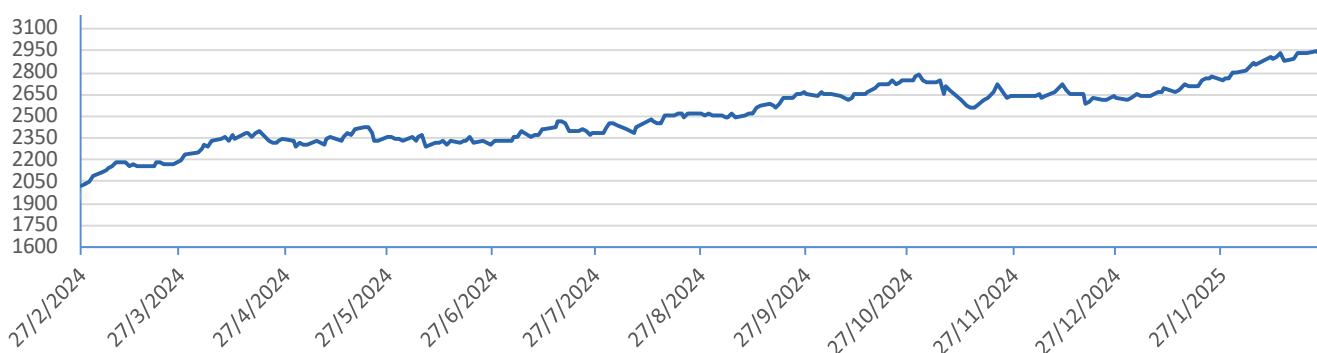

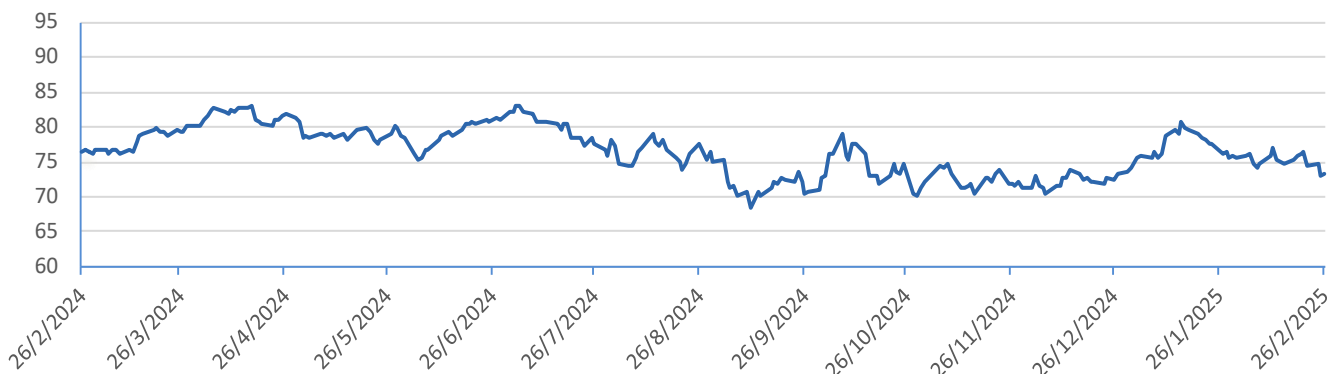
Gold spot (\$/Oz)

Brent Crude Oil (Future)



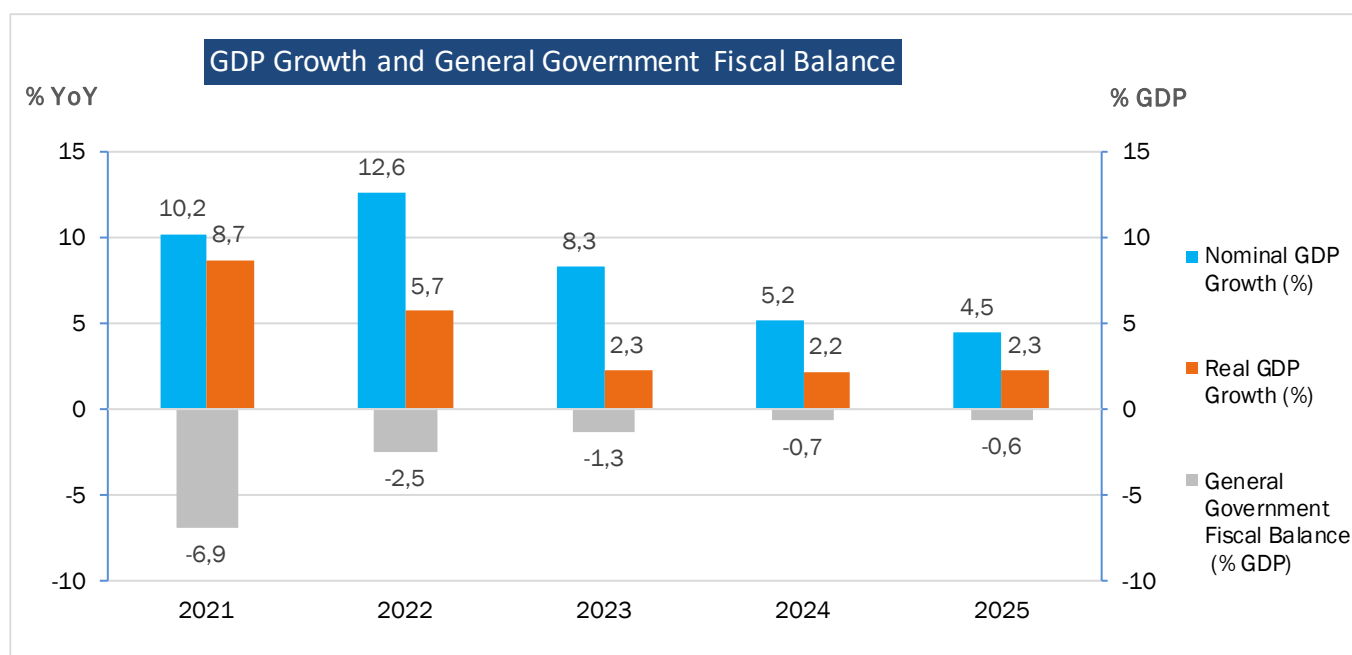
