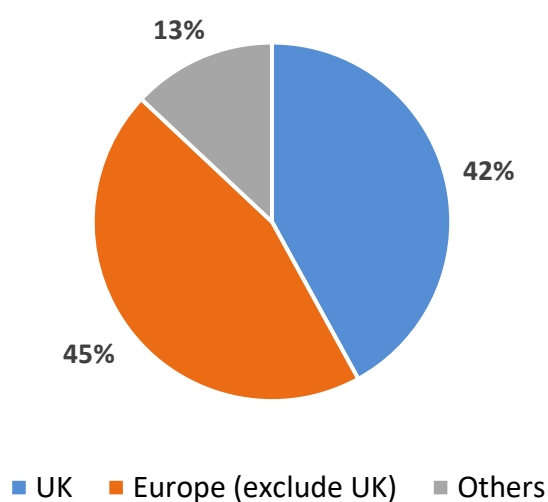

Distribution by Investor Type



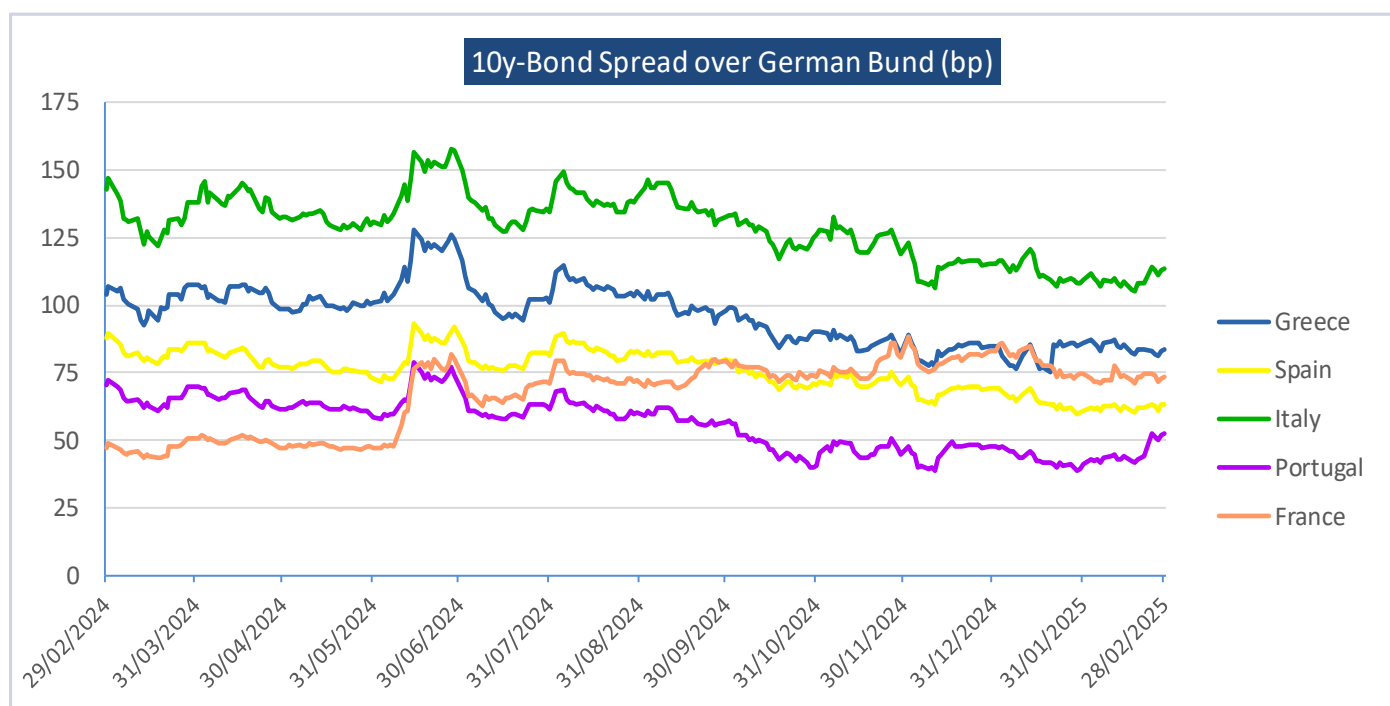
Distribution by Geography

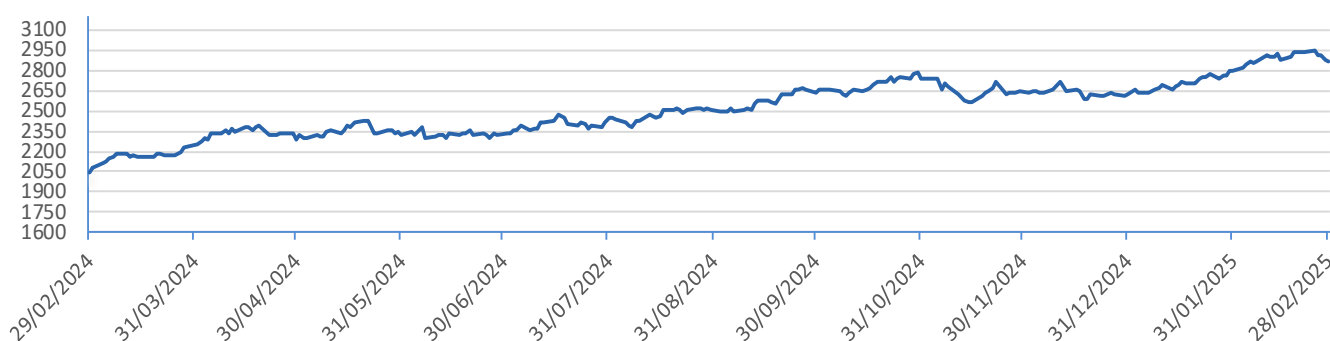

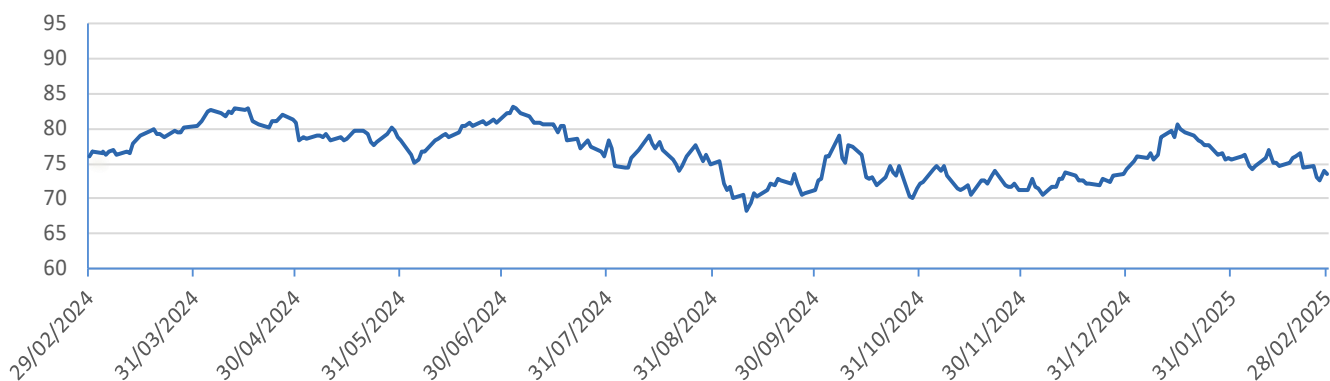
Gold spot (\$/Oz)

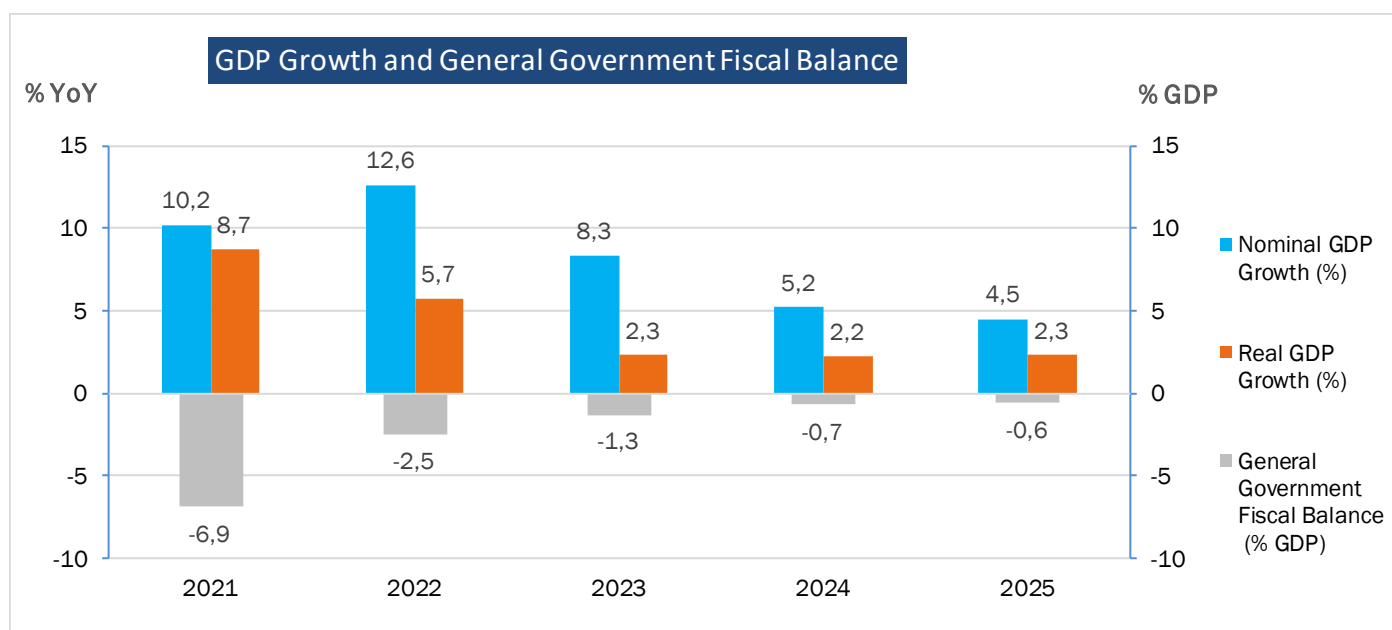
