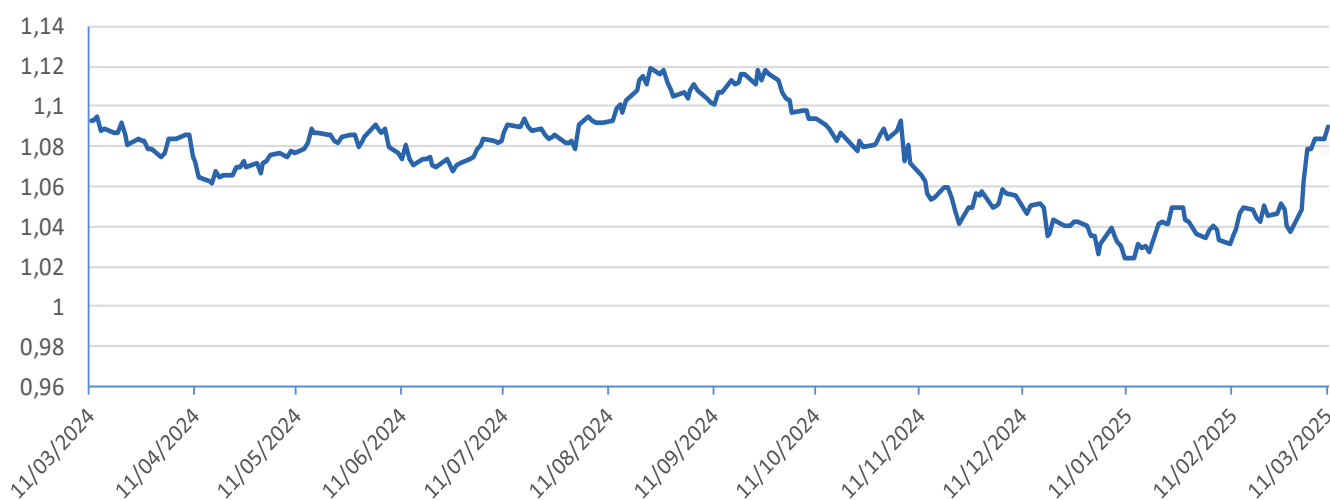

EURUSD spot rate



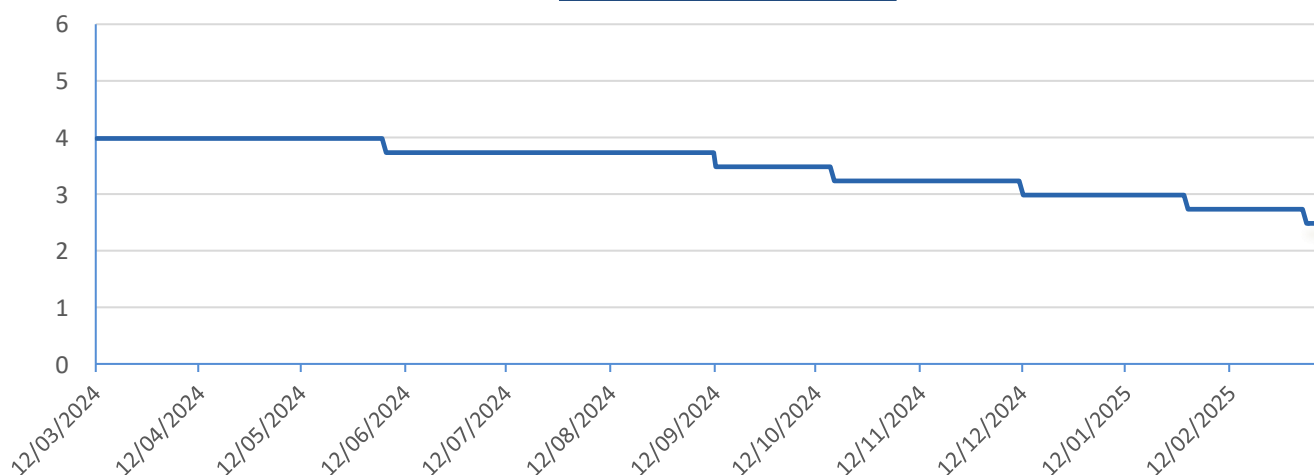

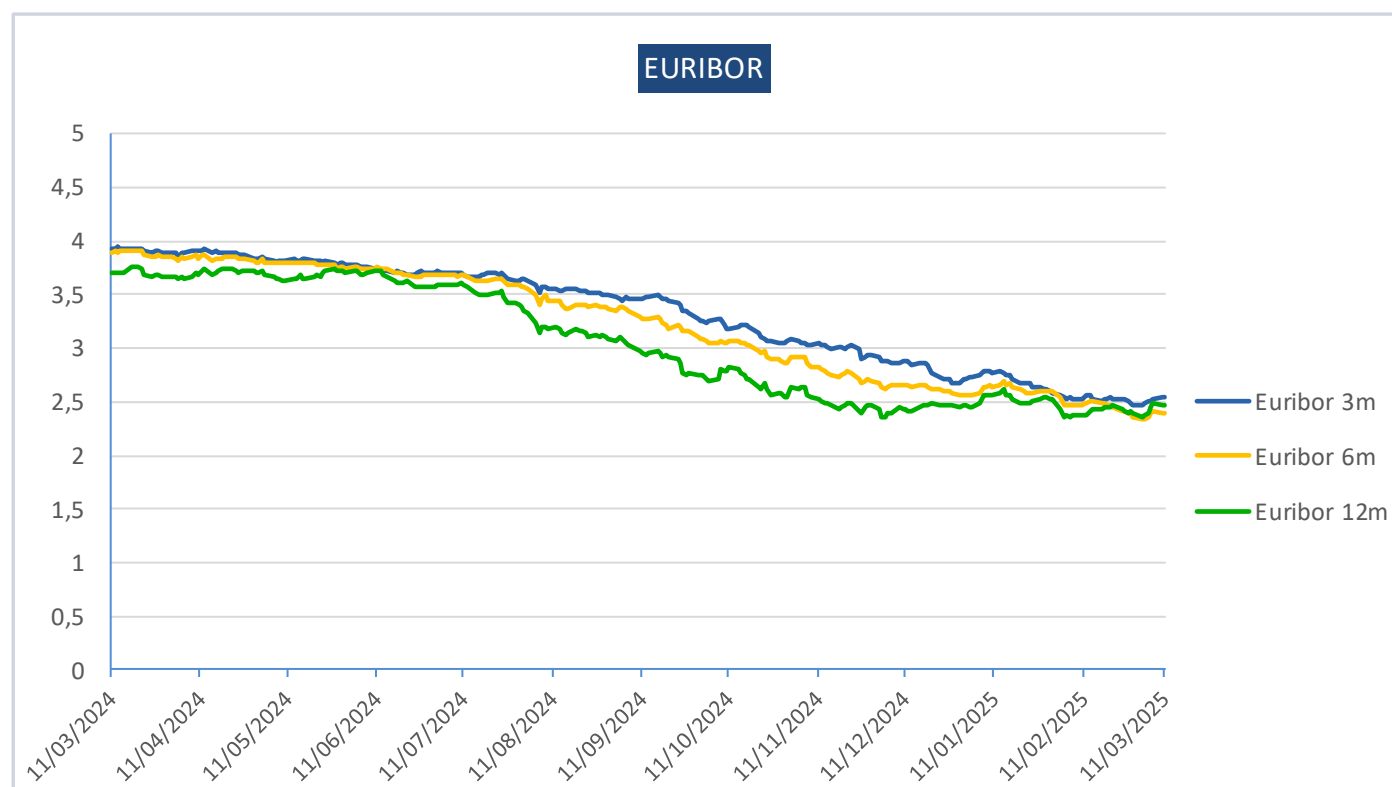
ECB Deposit Facility Rate

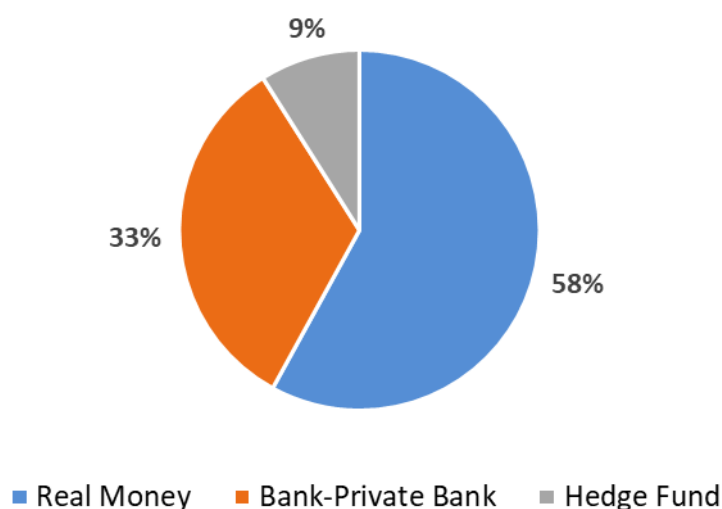

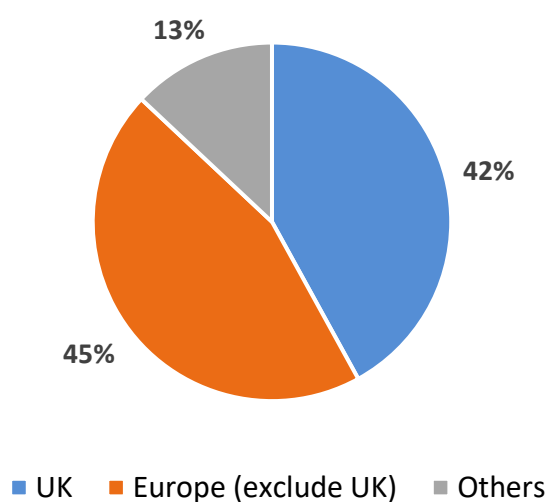

Distribution by Geography

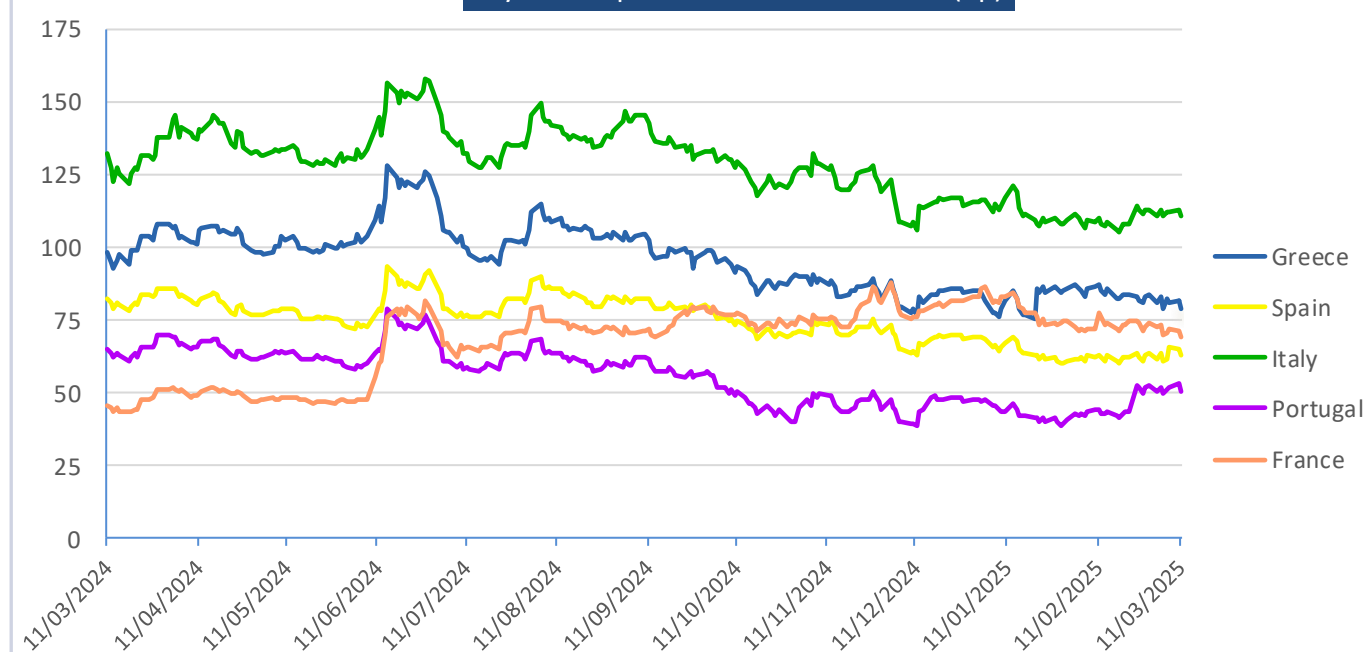

BONDS SPREAD OVER GERMAN BUND (bp)

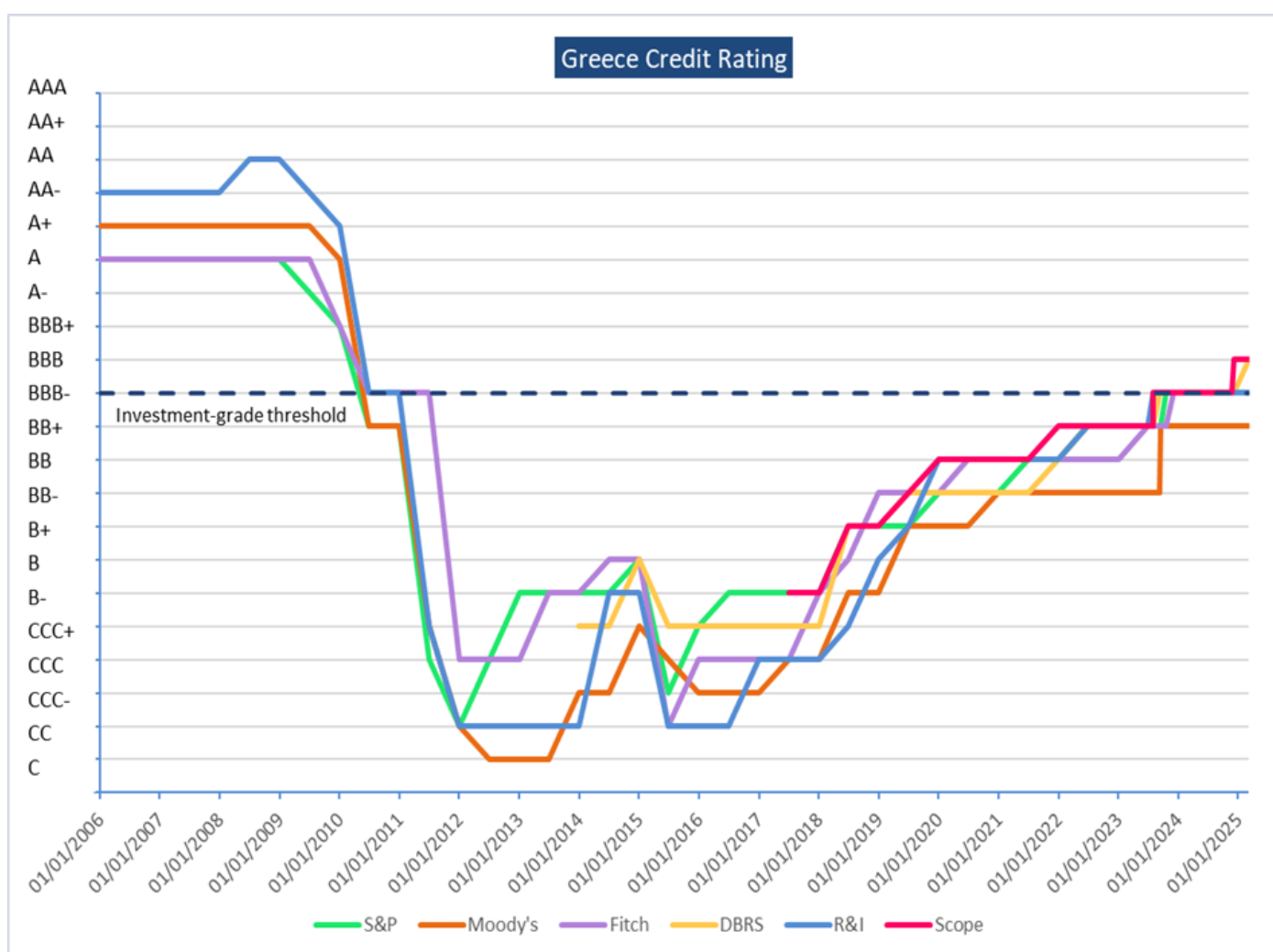

10y-Bond Spread over German Bund (bp)




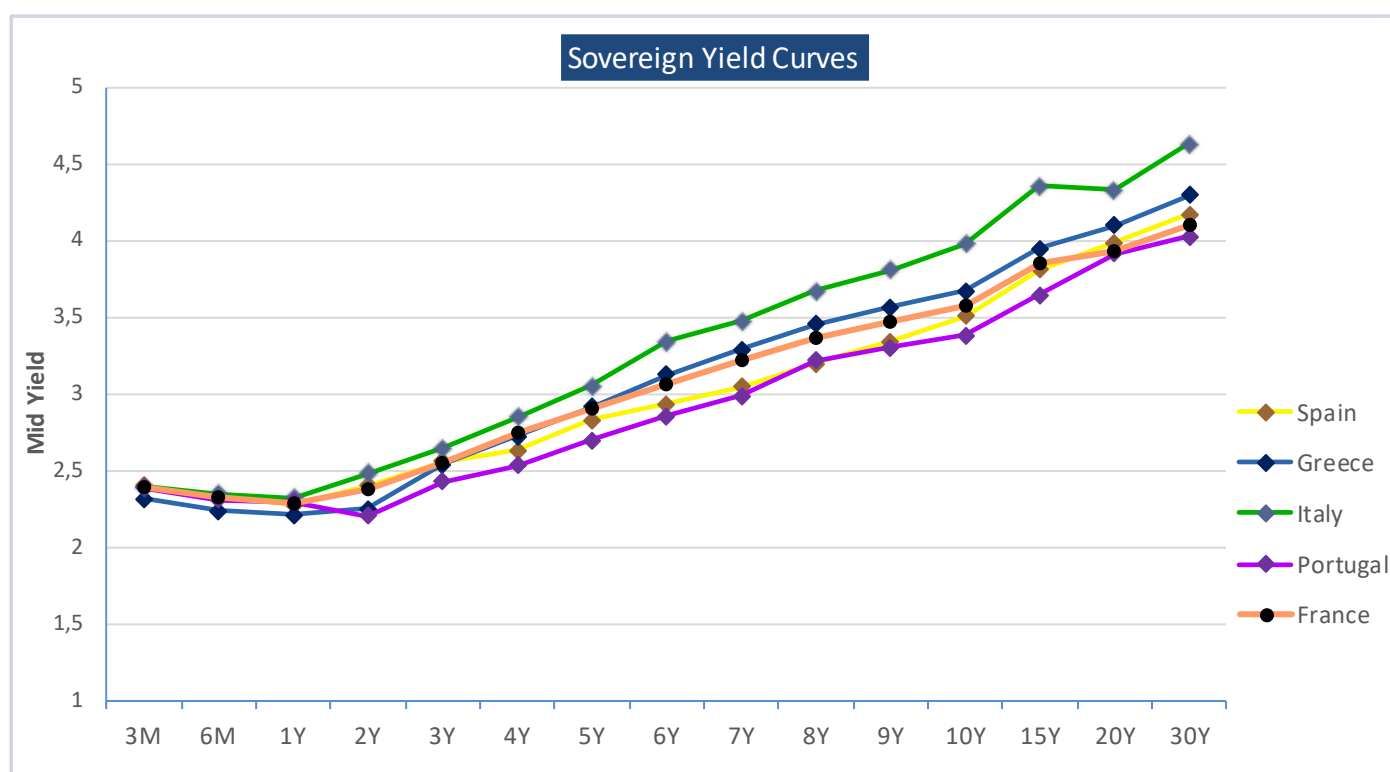

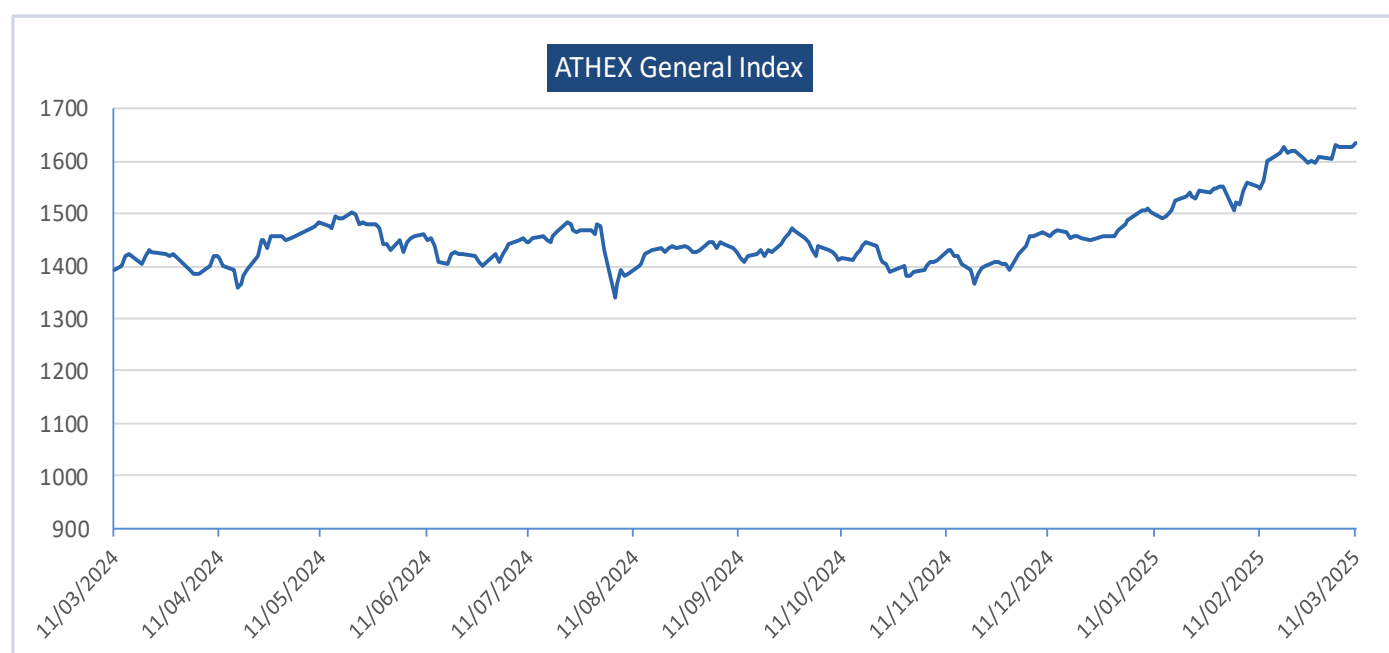

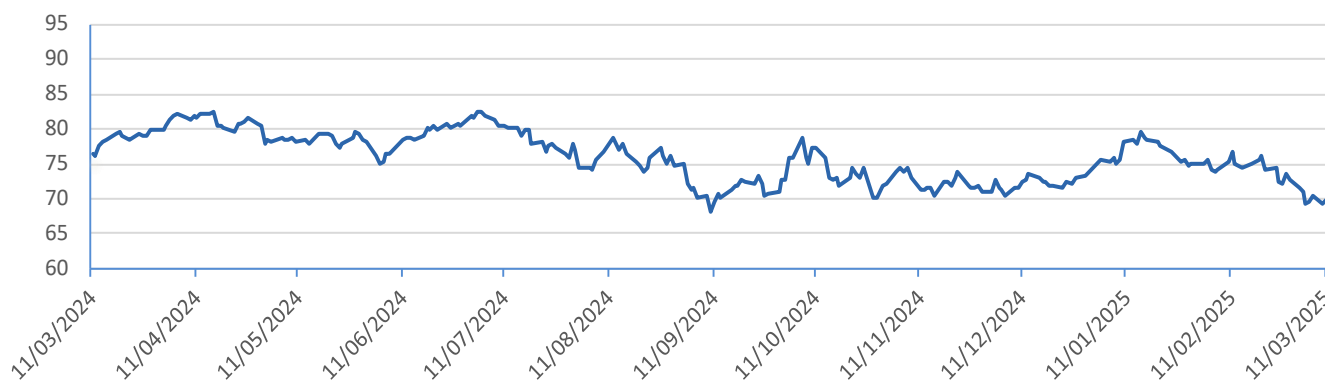
Gold spot (\$/Oz)

Brent Crude Oil (Future)



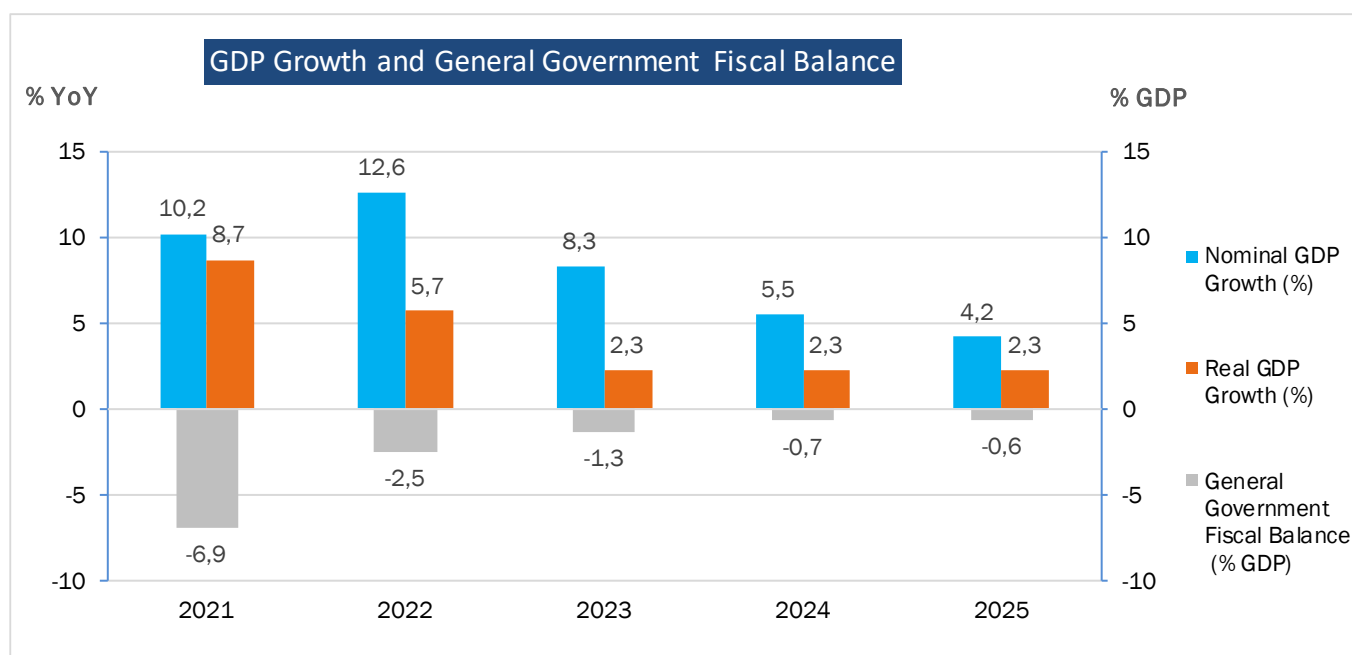
