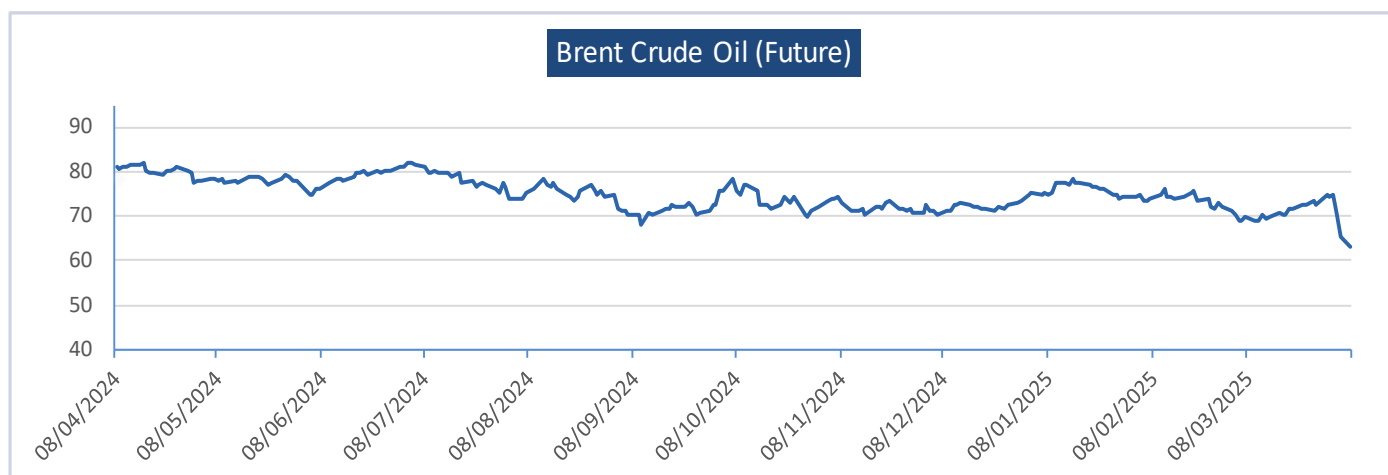
Gold spot (\$/Oz)

Brent Crude Oil (Future)



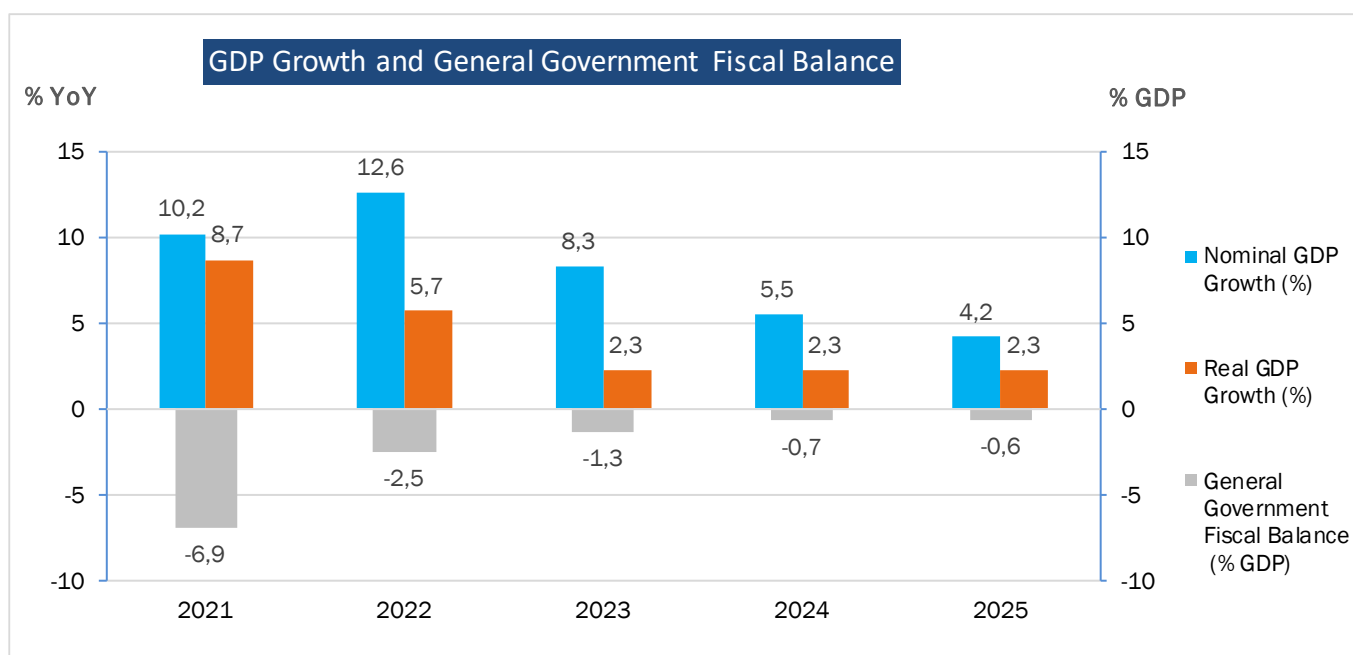
