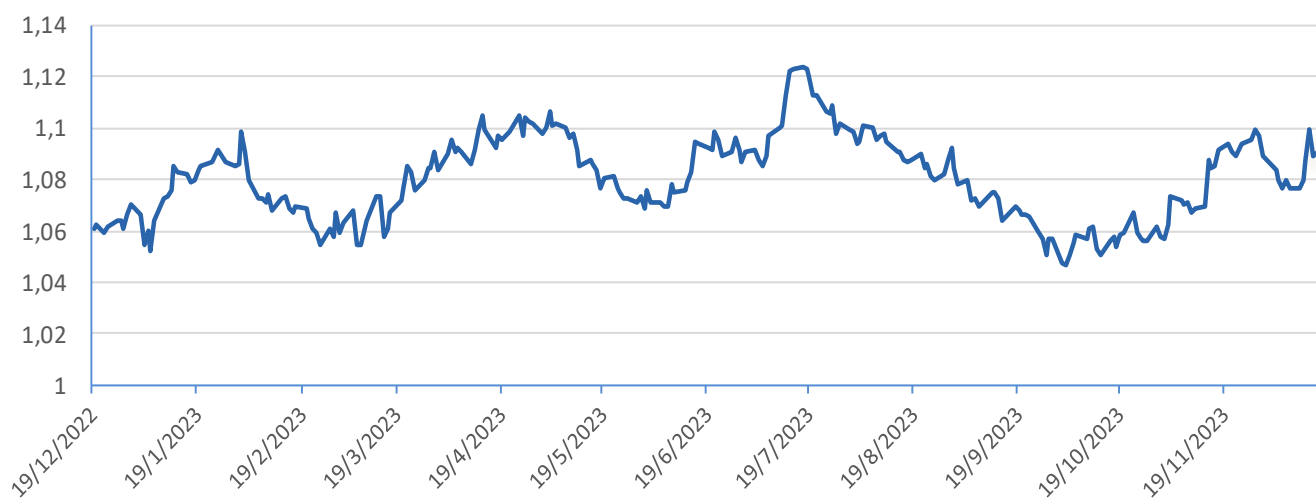

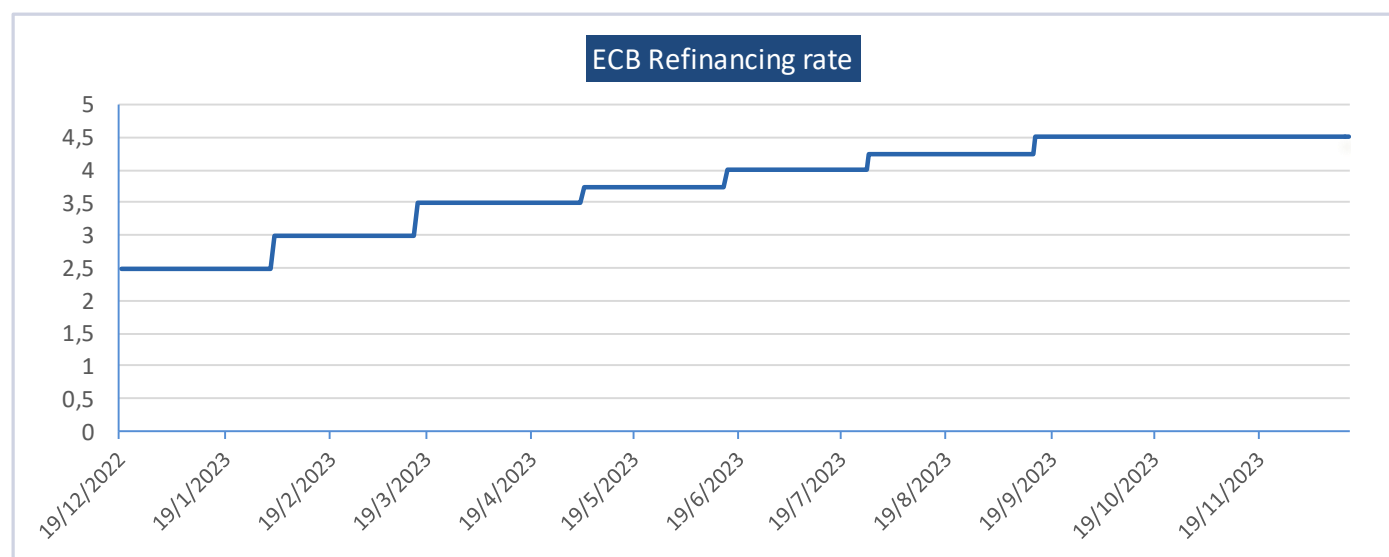
EURUSD spot rate

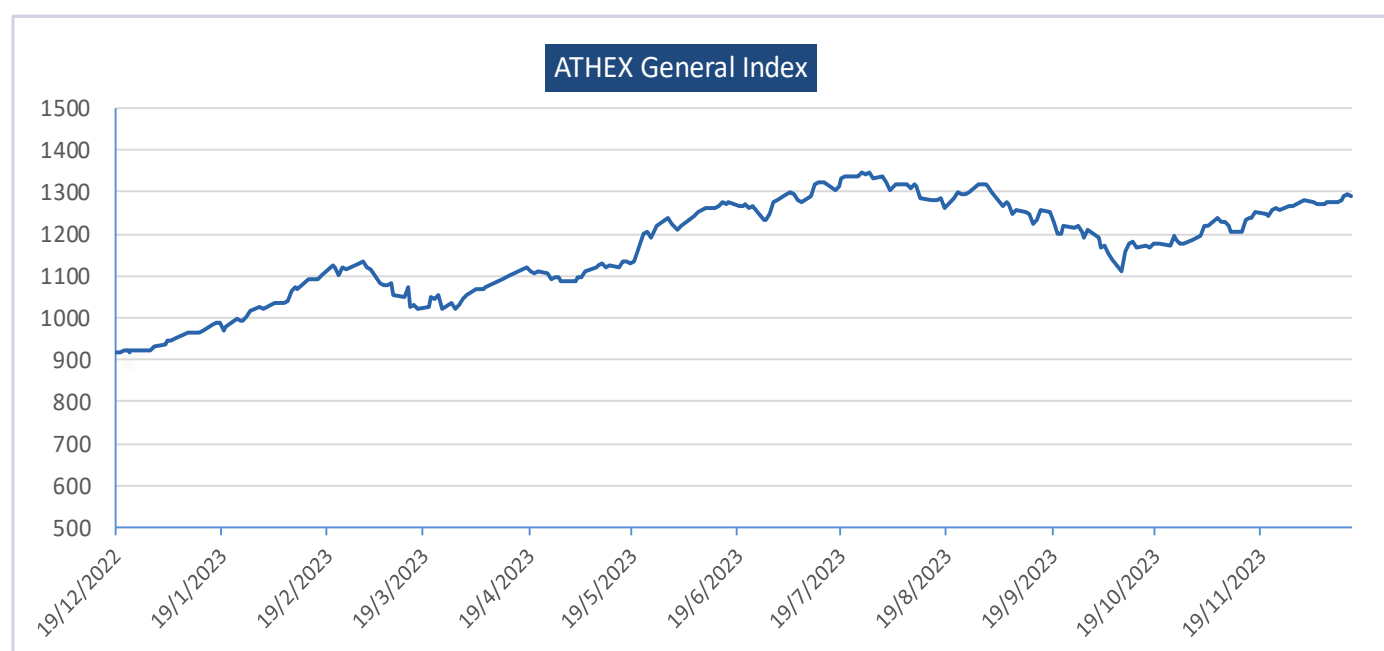

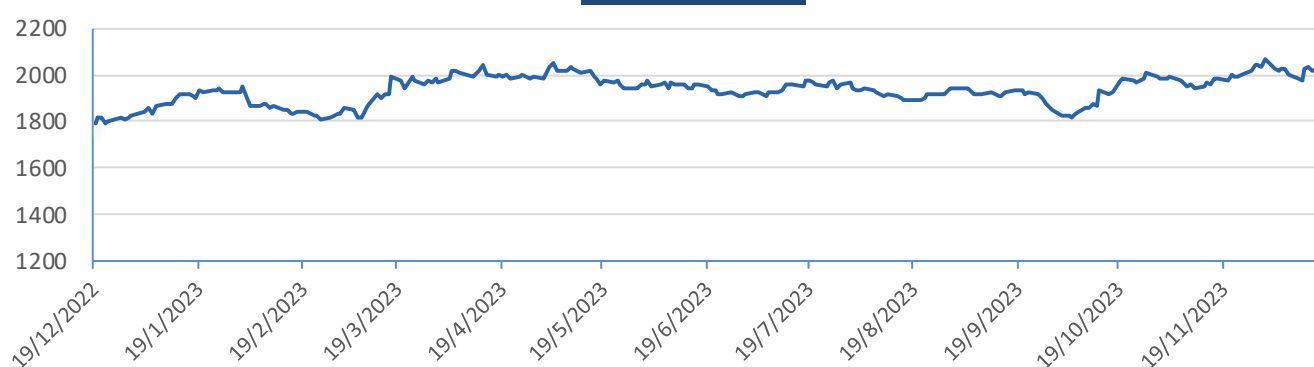

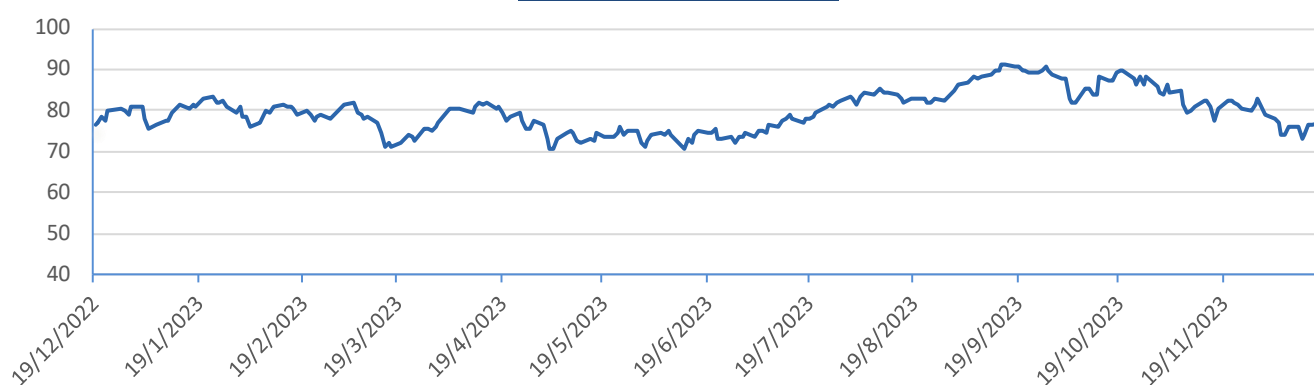
Gold spot (\$/Oz)
