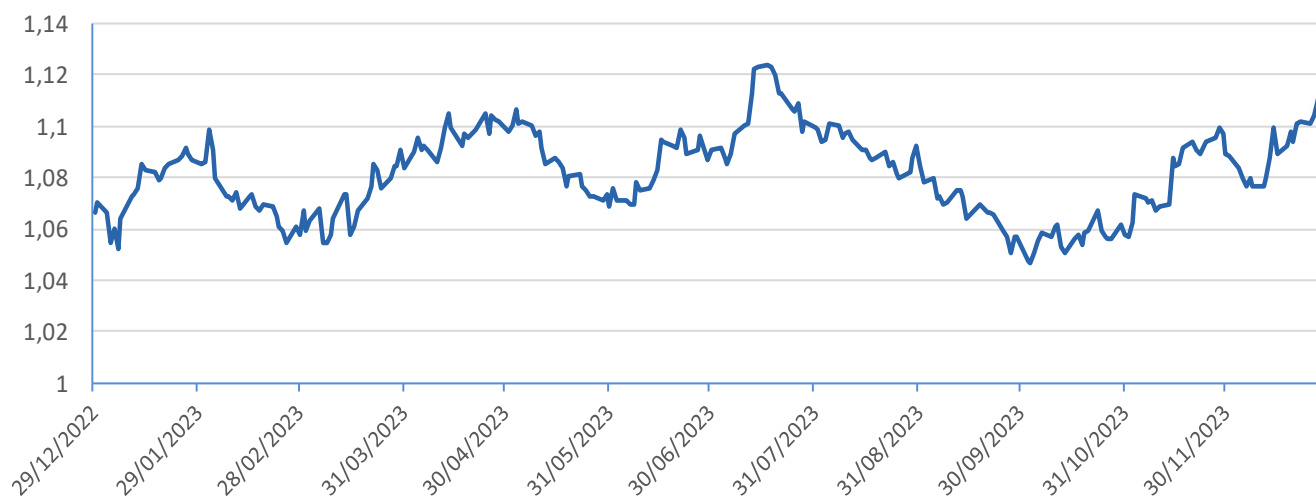

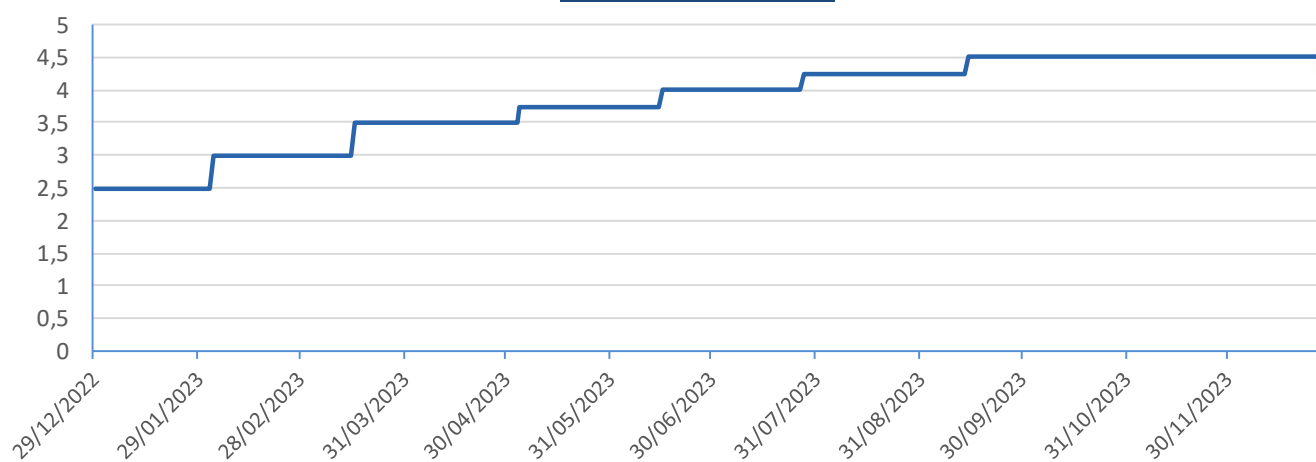

ECB Refinancing rate

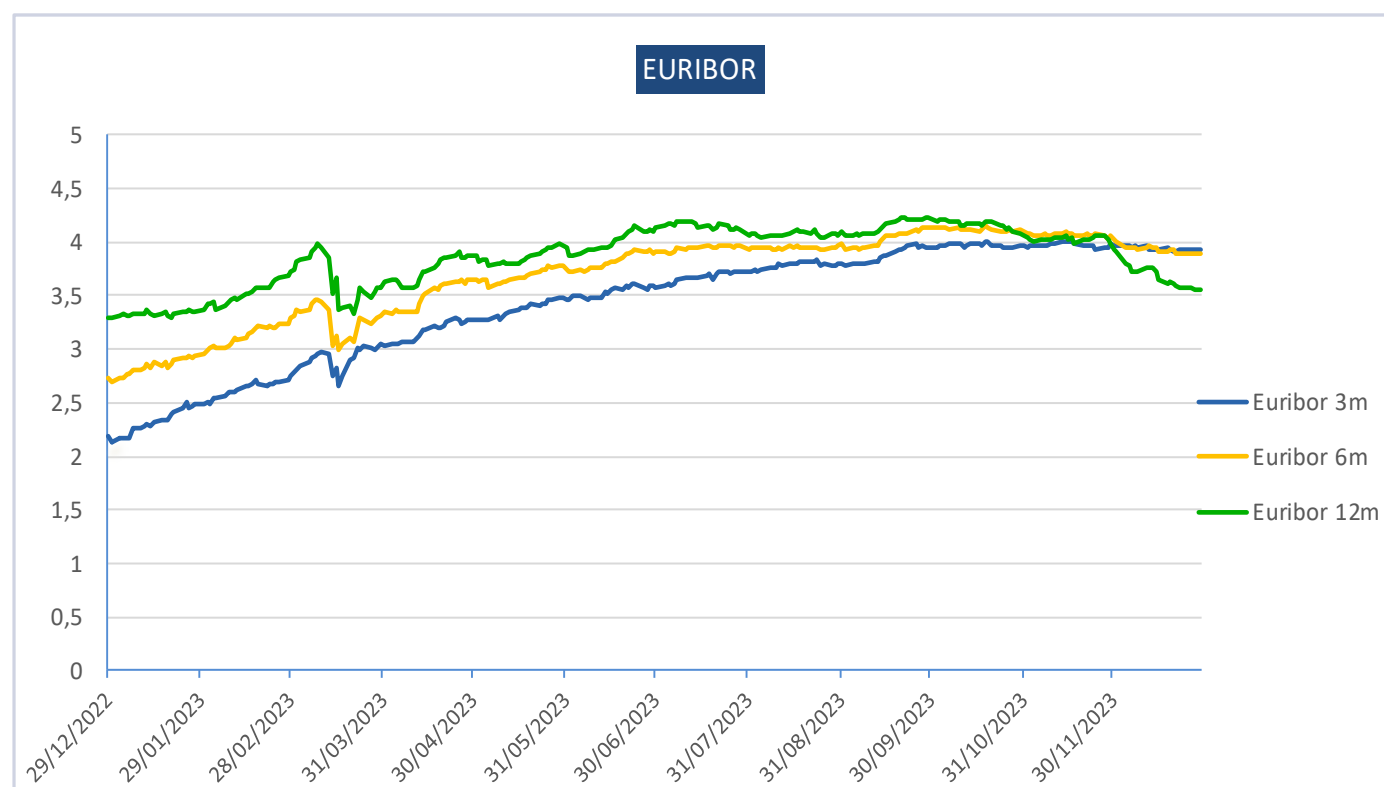

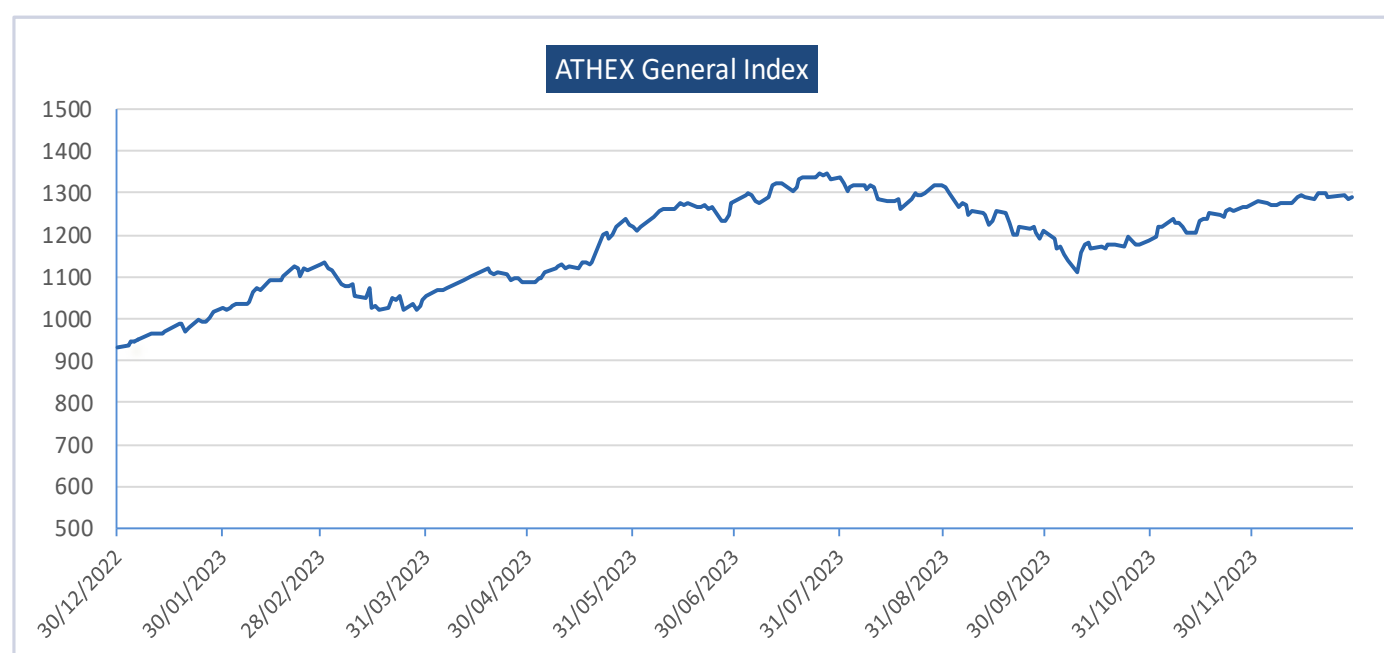
