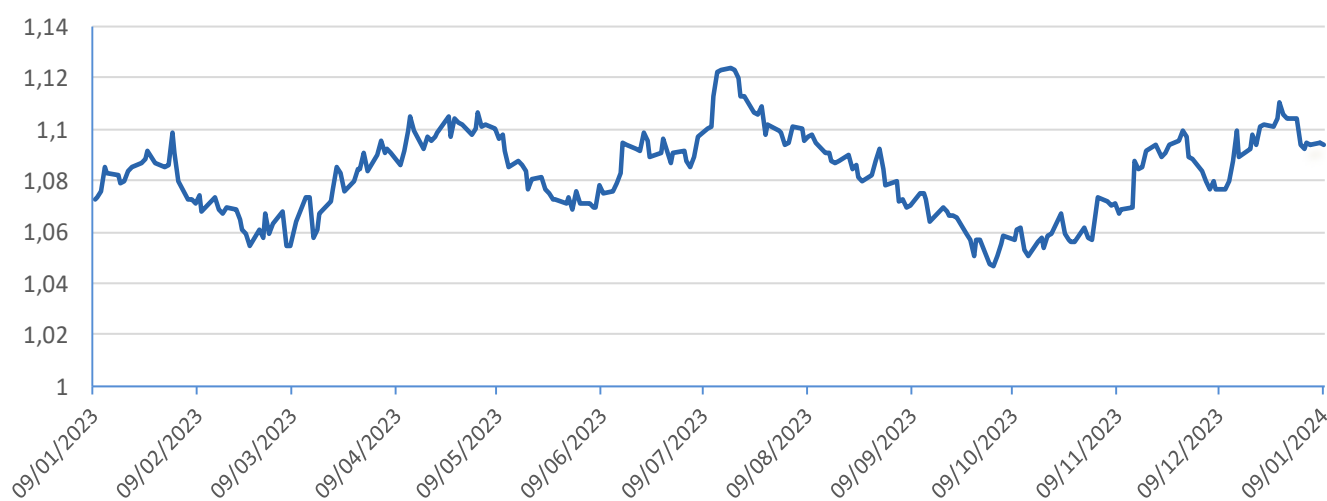

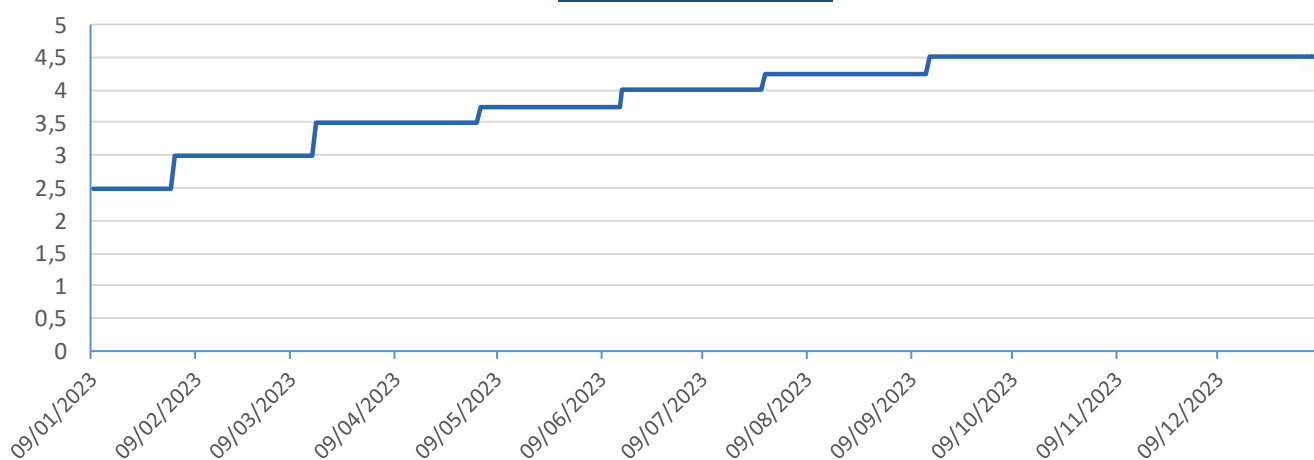

ECB Refinancing rate

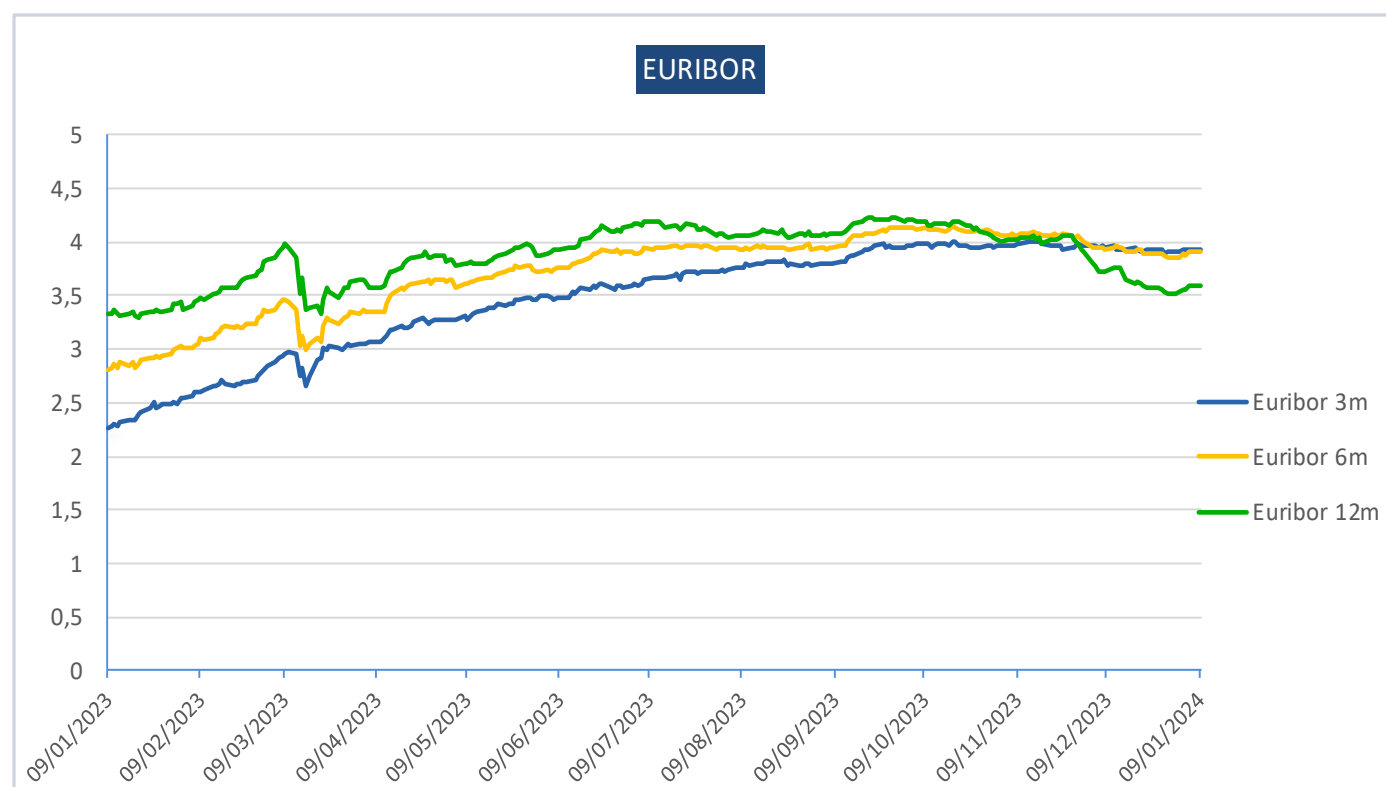

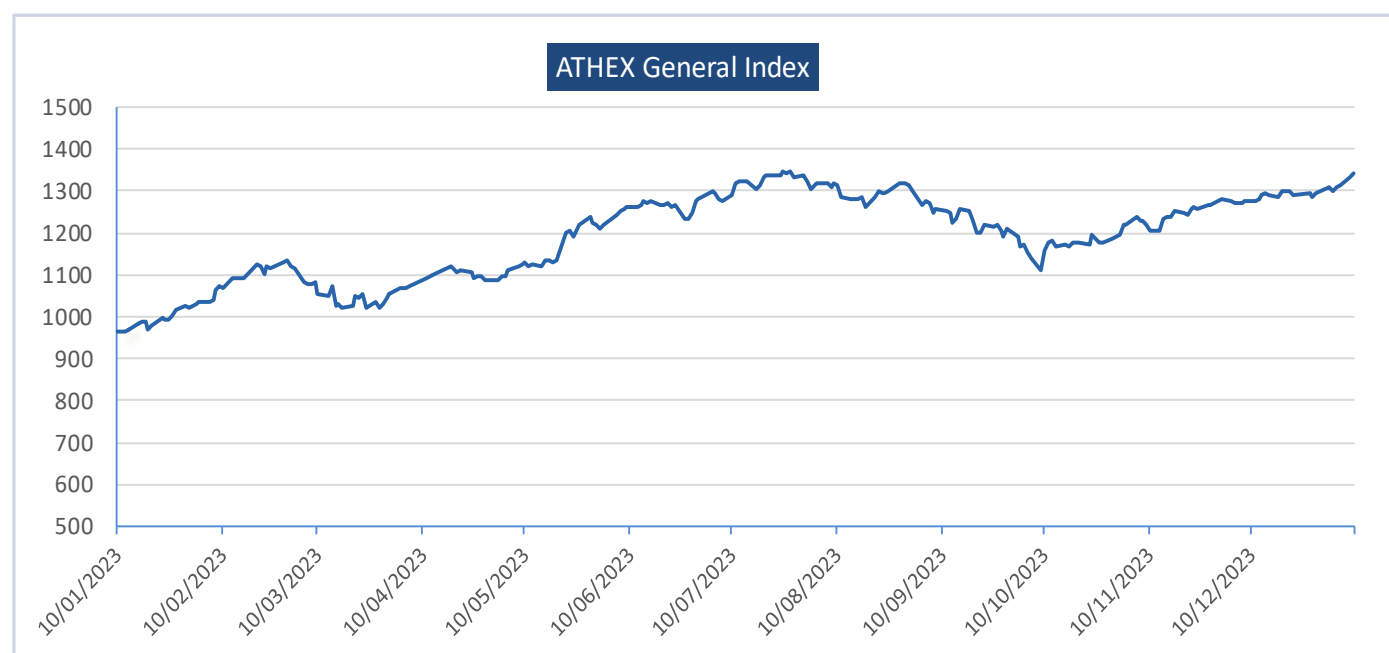

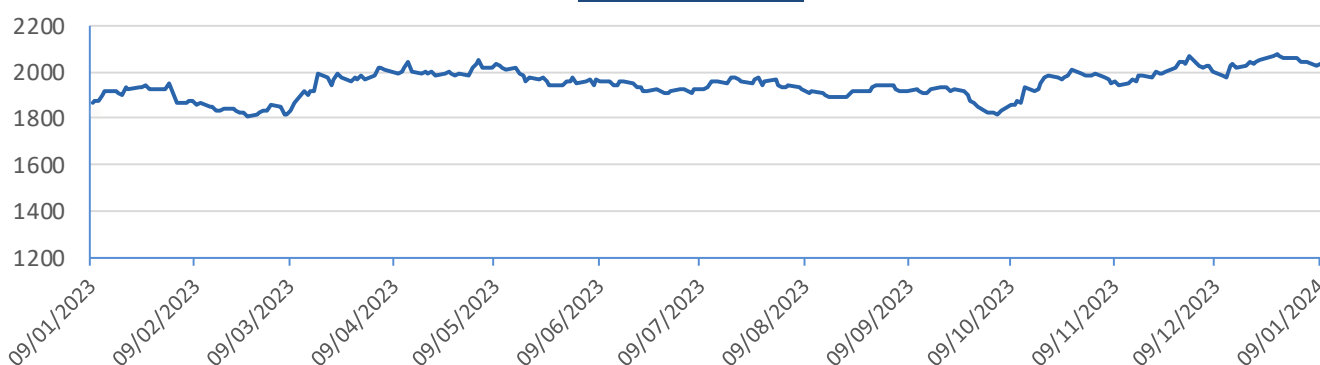

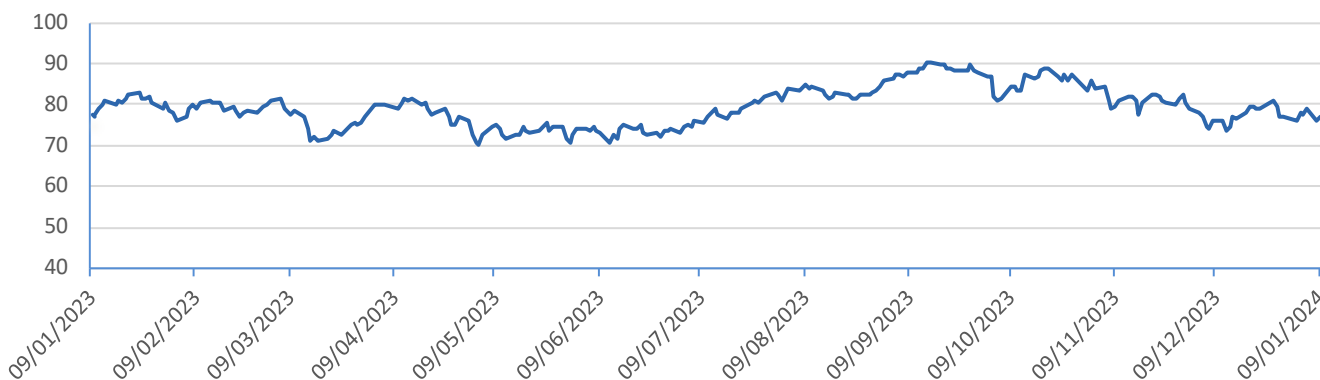
Gold spot (\$/Oz)
