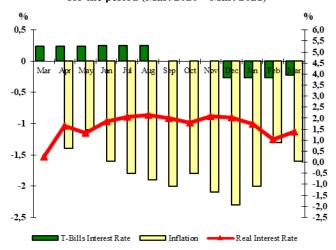

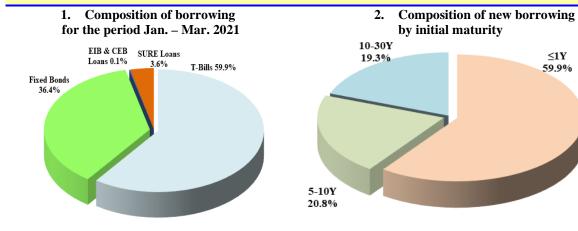

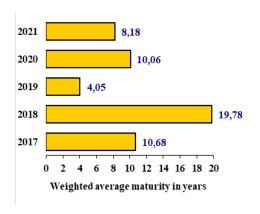

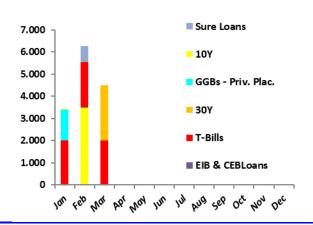
C. New Borrowing* (Jan. – Mar. 2021)

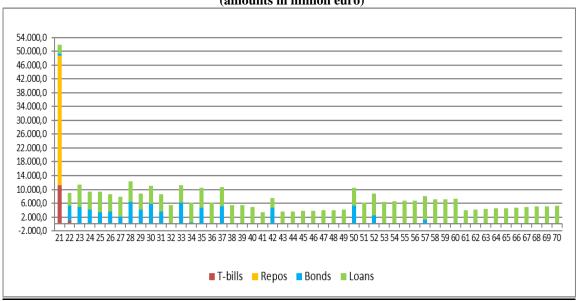

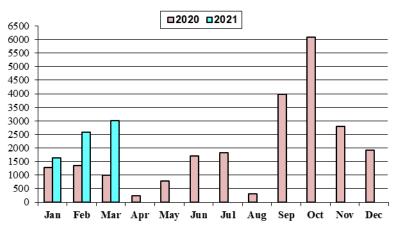
5. Redemption schedule of Budgetary Central Government Debt on 31/03/2021 (amounts in million euro)

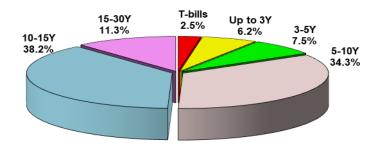
